Meadows Union School District Sufficiency of Textbook & Instructional Materials for 2019-2020 Resolution Number 091019-02

WHEREAS, Education Code Section 60119 establishes steps and procedures to ensure the availability of textbooks and/or instructional materials for pupils on a yearly basis in each of the following subjects, as appropriate, that are consistent with the content and cycles of the curriculum framework adopted by the State Board:

- 1. Mathematics
- 2. Science
- 3. History-Social Science
- 4. Reading/language arts, including the English language development component of an adopted program; and

WHEREAS, pursuant to Education Code Section 60119, subdivision (c)(1), sufficient textbooks or instructional materials means that each pupil, including English Learners, has a textbook or instructional materials, or both, to use in class and to take home to complete required homework assignments, although this does not require two sets of instructional materials for each pupil; and

WHEREAS, photocopied sheets from only a portion of a textbook or instructional materials copied to address a shortage are not considered sufficient textbooks or instructional materials pursuant to Education Code Section 60119, subdivision (c)(2); and

WHEREAS, if the governing board determines that there are insufficient textbooks or instructional materials, or both, for each pupil in each school of the district, the board is required to provide information to classroom teachers and to the public setting forth the reasons that the insufficiency exists; and the board is required to take appropriate action to correct the insufficiency within two months of the beginning of the school year in which the determination is made; and

WHEREAS, the public hearing shall take place on or before the end of the eighth week form the first day pupils attend school for that year; and

WHEREAS, the Board is required to provide 10 day notice of the public hearing or hearings and the notice shall contain the time, place, and purpose of the hearing and shall be posted in three public places within the school district.

WHEREAS, the governing board is required to encourage the participation of parent, teachers and members of the community interested in the affairs of the district, and bargaining unit leaders; and

WHEREAS, the hearing shall be held at a time that will encourage the attendance of teachers and parents and guardians of pupils who attend the school(s) in the district and shall not take place during or immediately following school hours; and

WHEREAS, a properly noticed public hearing meeting the foregoing requirements was held on September 10, 2019.

THEREFORE, BE IT RESOLVED,

- 1. The Governing Board determines that each pupil in the Meadows Union School District has available sufficient textbooks or instructional materials, or both, within the meaning of Education Code Section 60119, subdivision (c)(1) in each subject listed above that are consistent with the content and cycles of the curriculum framework adopted by the State Board and adopted by this Board in accordance with established procedures.; and
- 2. The Governing Board also determines that each pupil enrolled in a foreign language has sufficient textbooks or instructional materials that are consistent with the content and cycles of the curriculum framework adopted by the State Board for these subjects;
