Superintendent

Dr. Oest notified the Board that a request for an extension to a previously approved FMLA Leave of Absence would be forthcoming. The request will be officially acted on at the August meeting, though administration will prepare accordingly to cover the leave of absence. A NMS aide position is currently vacant, though has been posted and will be filled in time for the start of school. Other items shared include:

- Reminder for Board members to notify the district office regarding Tri-Conference attendance in November
- An update was provided on the NMS project
- NMS and RGS phones have been installed and are operational with SGE to follow. Communication of the new SGE phone number was discussed with Mr. Pittman. The update will be shared with the community.
- A spreadsheet to track enrollment, previously provided to the Board, was shared with them again, now including the addition of 2 new columns; a "July 19th

enrollment" was added and a column showing class sizes based on the July 19th enrollment. RGS had 499 students in March. July enrollment is down by approximately 50 students. SGE had 399 students in March and July enrollment is at 346. The expectation is to see a similar situation over the next few years. RB enrollment is expected to decrease to fewer than 700 students in the next 5 years.

Business Manager

Mrs. Levendoski shared that the combined Districts total, approximately \$8000 was approved from FEMA through the IEMA grant related to the snow storm this past winter. D2 should receive approximately \$6000 in 6-8 weeks. The budget is the focus of the business department during the upcoming month. The audit has been scheduled for August 8-10. The state of Illinois currently owes District 2 approximately \$408,000 in back transportation and Special Education dollars.
