# **New Business**

- **Student Enrollment** Included in your packet is the current student enrollment and class sizes. I've also included the most recent NESDEC data to compare.
- Increase to Substitute Teacher Pay As you know, substitute teaching has been an ongoing issue across the state. We've heard from substitutes that they are taking other jobs because we pay lower. I recommend that we move our current pay of \$75.00 per day to \$90.00 per day.
