Mountain View Middle School is Schoolwide Title I with 67% of students receiving free or reduced lunch.

 - The school's reading teachers and parent volunteers will create a pamphlet explaining
 the school's involvement with the state's reading initiative and how the parents can be
 involved in supporting the goals of this initiative. It will be distributed at parent orientation
 night and other public meetings.

 Homework assignments and pertinent classroom information will be available on the Web sites.

 - Alert Now- Blackboard Phone notification system is used to contact parents about upcoming events, notices, and reminders.

- An online Event Calendar is available on the school Web site with upcoming events, meetings, school pictures, testing schedules, and student activities.
- Teachers routinely contact parents on an individual basis to communicate about their child's progress.
- The school will provide to parents reports/report cards every interim and the end of each grading quarter with information regarding their child's academic progress and upcoming classroom and school events.
- The school will give parents a parent-friendly letter at the beginning of the year that
 explains their child's test results and standardized test scores from the previous school
 year.
- The school will send brochures home with students, post notices in school facilities and public buildings, and provide information for local newspaper (Stone County Leader) and radio station (Arkansas 103.3 KWOZ) about parent workshops and meetings.
