- 1. What are the various communication strategies that your school uses to provide additional information to parents and to increase parental involvement in supporting classroom instruction?
  - The school will use the Blackboard system and remind me 101 (a text messaging service) to inform parents of events and activities that will involve students in the school setting.

- 3. How will your school provide information to parents about volunteer opportunities?

- The school will provide opportunities for parents and community members to support the instructional program through such programs as Music roots program, Rural Special Choir, and book fair helpers.
