

AMERICAN BOARD (ABCTE)

- Hold a Bachelor's degree from a regionally accredited college or university. Candidates must hold a minimum 2.75 GPA or higher*
- 2. Complete the American Board program by passing the required pedagogy and subject area exams.
- 3. Spend 60 hours (6-12) or 90 hours (elementary) in a school working with children. Hours must be validated by the school principal. These hours can be completed in one of the following ways:
- a. Spend 60/90 hours substitute teaching in a public school classroom. You must be the lead instructor for at least 45 of these hours.
- b. Spend 60/90 hours substitute teaching in a public school or an accredited non-public school with at least 30 consecutive hours in the same classroom.
- c. Spend 60/90 hours teaching as a paraprofessional in a publischool or an accredited non-public school.
- *Elementary Educator applicants: 90 hours as a substitute teacher or paraprofessional in a public school or accredited nonpublic school classroom is required, of which at least 30 hours must be completed in an elementary classroom.
- 4. Apply to the Missouri Department of Elementary and Secondary Education (DESE) for the Missouri Initial Professional Certificate (IPC) or License to Teach. This is valid for 4 years. You are now ready to begin applying to school districts and are considered to have a professional teaching certificate.
- 5. Once you secure a position in a Missouri school and begin teaching you will have 4 years to upgrade your IPC to a Career Continuous Professional Certificate (CCPC), a renewable teaching certificate. You will become CCPC eligible after completing teaching experiences mentoring, professional development, performance evaluations, and more.
- *To satisfy Missouri state requirements, candidates must submit to American Board all transcripts from all institutions at which course were taken. Every course will be included in the calculations to mee the 2.75 GPA minimum

TEMPORARY AUTHORIZATION CERTIFICATE (TAC)

- 1. Possession of a baccalaureate or higher degree from an accredited college or university in the subject area to be taught or a closely related field (applicants for a special education temporary authorization must possess a baccalaureate or higher degree) with a content area GPA of 3.00 on a 4.00 scale;
- Submission of a joint application verifying contracted employment with a Missouri public school district or accredited non-public school;
- 3.If the applicant holds an initial Missouri professional certificate of license to teach, a transcripts analysis must be completed by the Office of Educator Certification based on the requirements set forth in 5 CSR 20-400.180; and
- 4.The temporary authorization certificate will not include elementary (1-6); early childhood (B-3); early childhood special education (B-3); blind and partially sighted (K-12); deaf and hearing impaired (K-12) or counselor areas. Applicants for the areas of driver's education, English language learners, gifted education, and special reading must already hold a professional certificate of license to teach.



SUBSTITUTE CERTIFICATION

Must have 60 college credit hours or have taken the 20 clock hours of approved substitute teacher training from DESE (the Missouri Dept. of Education). You will be reimbursed the \$180 fee after subbing for the district for 3 days. An application packet may be picked up at 860 W. Vest.

PARAPROFESSIONAL CERTIFICATION

The requirement that instructional paraprofessionals be qualified applies to all public elementary or secondary instructional paraprofessionals employed by a local education agency and funded with federal funds. All instructional paraprofessionals in a schoolwide building must meet the instructional paraprofessional qualifications. Instructional paraprofessionals funded with federal funds in a targeted building and all instructional paraprofessionals in schoolwide building must have; 60 College Hours OR, Passed the Para Pro Assessment (Before September 23, 2013) OR, Passed the Paraprofessional Assessment(September 23, 2013 or after)This information is reported by districts in the Highest Degree field in the October MOSIS Educator Core File and should be available during monitoring.
