The Board of Education of the School District of Marshall met in regular session on Tuesday, May 24, 2022 at Spainhower Primary School at 6:00 p.m.

Present: President Bryon Jacques and Members Erin Meyer, Matt Smith, Harry Carrell, Ellen Lance, Jack Lenz, and Brad Shepard by zoom. The board took a moment of silence to remember those killed in a school shooting in Texas.

On a motion by Mrs. Lance, seconded by Mr. Lenz, the board unanimously approved the minutes of the April 26 regular board meeting and the April 22, May 11, and May 18 special board meetings.

On a motion by Mrs. Lance, seconded by Mr. Smith, the May bills totaling \$1,641,366.33 were unanimously approved.

On a motion by Dr. Meyer, seconded by Mrs. Lance, the monthly finance reports were unanimously approved.

On a motion by Dr. Meyer, seconded by Mrs. Lance, the board unanimously approved GATE Program Review.

On a motion by Dr. Meyer, seconded by Mr. Smith, the board unanimously approved the A+ Program Review.

On a motion by Dr. Meyer, seconded by Mrs. Lance, the board unanimously approved the Early Childhood Program Review.

The first Reading of the 2022A MSBA Policy UPdates was held. These will be adopted at the July meeting.

Discussion of a Success Driven Student Behavior Assistant was added to the agenda. On a motion by Mrs. Lance, seconded by Mr. Smith, the board unanimously adopted the agenda for the remainder of the meeting.

Bryon Jacques announced that the following will be recognized at the Central Missouri School Counselor Association's meeting next week in Warrensburg: Administrator of the Year - Kim Alberson and School Counselor Advocate of the Year - Lindsey Parton.

Carol Maher, Superintendent, reported to date, 52 employees have resigned/retired as of the end of the 2021-23 school year. Information presented on budget amendments is as follows: ESSER II Revenue (received) \$2,138,793; ESSER III Revenue (approximately) \$1,500,000; Insurance Recovery (current) \$605,481 which equals \$4,244,274. Amendments to the budget are as follows: March, 2022 - \$768,825 and May, 2022 - \$1,966,069.

Some districts are re-establishing Career Ladder which is funded 40% by the state and 60% by the district. No conference schools are participating. The administrators of the district are requesting a 5.2% raise to reflect the average teacher raise and those given to the classified staff. A request was made to calculate a flat \$2,000 raise, with a yearly step included of \$765. Increases in the budget line would be as follows: 5.2% raise = \$141,808 and a \$2,000 raise = \$107,975.

The latest test of air quality in the high school shows numbers that are lower than the last test. Numbers for the presence of formaldehyde are very low.

Projects in the district that have been funded by ESSER include the following: After-school Tutoring Program; Back on Track Program; HVAC at BMS and MHS trailer; replacement doors at IA Building, BMS, and SCCC; demolition of building for green space at BMS; digital sign at Central Office; automation systems in all buildings; air filtration in all buildings; and fiber ring upgrading.

Projects that the district has funded include the following: football field, track, and soccer field; MHS fire alarms, lighting, and flooring; cooler/freezer MHS; cameras installed - MHS, BMS, SCCC, Bus Barn, NW, SPS; technology - student devices, smart boards, projectors; vape sensors; new elevators at SPS, BMS; and PN building renovation.

Revision of salary schedule Policy GCBA was discussed. Currently the policy states an employee may not advance more than one step vertically and two columns horizontally per year on the salary schedule unless such movement is allowed by the board-adopted rules and is uniformly applicable to that particular salary schedule or is otherwise approved by the board. Dr. Maher recommended the policy be changed as follows: An employee who earns a higher degree within a calendar year may advance to the column representing that degree, rather than being limited to a two-column movement per year. On a motion by Dr. Meyer, seconded by Mr. Carrell, the board unanimously approved the recommended change.

Revision of advertising Policy KI was discussed. Currently the policy states the district may accept or solicit advertising for use on the district's website and in gymnasiums, athletic fields and other facilities primarily used for extracurricular activities. Any such advertising will be limited to the name, address, phone number, Internet address and logo of the advertiser. Dr. Maher recommended the policy be changed as follows: The district will not enter into a sole agreement with a specific business that would limit the number of advertisers on any district or building signage. On a motion by Mrs. Lance, seconded by Mr. Carrell, the board unanimously approved the recommended change.

On a motion by Mrs. Lance, seconded by Mr. Smith, the board approved the budget amendments.

Administrator salaries for the 2022-23 school year were discussed. On motion by Mrs. Lance, seconded by Mr. Smith, the board approved a 5.2% increase for administrators. The motion carried on the following vote:

Daniel Wright, Communication Director, reported on a conference he had attended. He also asked for a \$500 stipend for eight people to help with the district communication.
