Under the Superintendent's report, Mrs. Simmons-Kenser presented the 2019-20 tentative budget and directed the Board to set the date and time for the Budget Hearing as September 16, 2019, at 6:30 P.M. She projected revenue to be \$5,610,234 and expenditures to be \$5,949,113. She updated the Board with the final summer maintenance list and reported on a FOIA request from Smart Procure and Charter Schools Applications. Mrs. Simmons-Kenser also reported on the District's disproportional finding from ISBE for Special Education placements. Projects out of the 1% tax have been coming along. The road work at the high school has been expanded to fix some of the bad spots in the road, since the drainage project bid came in lower than expected. The elementary steps have been completed and have a 1 year warranty. All the summer painting has been completed. The new playground equipment has been installed and is complete. The well discovered during the installation has been sealed and inspected by the Health Department.
