- a. Student, Staff, and Community Recognition Director Hueg read this month's recognitions for the following students and staff members:
 - Gretchen Rozeboom Congratulations on her team placing 2nd at the Wisconsin State High School Clay Target League Championship and finishing in 14th place at the USA High School Clay Target League National Championship.
 - ii. Congratulations to Ethan Boettcher on placing 3rd in the Wisconsin State High School Clay Target League Championship and placing 67th in the nation at the USA High School Clay Target League National Championship.

- iii. Congratulations to John Miles on placing 4th in the Wisconsin State High School Clay Target League Championship and on his accomplishments at the USA High School Clay Target League National Championship as an individual and team.
- iv. Congratulations to Abby Boettcher on placing 11th in the Wisconsin State High School Clay Target League Championship and on her accomplishments at the USA High School Clay Target League National Championship as an individual and team.

12) Core Agenda Items

- a. Designate Star Observer as the Official Newspaper for the St. Croix Central School District Previously at the board organizational meeting on May 20, 2019, the Board designated the New Richmond News as the official newspaper of the St. Croix Central School District; however, the newspaper recently merged with several other local newspapers to create the Star Observer. The River Falls Journal, Hudson Star Observer, and New Richmond News will merge its content into one new print publication that will cover all three areas. Motion Director Hueg, 2nd Director DeGross to designate the Star-Observer as the official newspaper of the St. Croix Central School District. Unanimously carried.
- b. Annual Summary Report on Bullying Behavior Trends and Recommendations by Director of Pupil Services Pat Basche Director Basche explained the data presented and how instruction is provided to students to make them aware of what bullying is and how to respond appropriately. The staff have been trained how to respond to bullying incidents and procedures for reporting bullying incidents. There are four categories of bullying behavior: physical, verbal, social, and cyber. Director Basche reported one documented incident at the elementary in 2018-19 compared to two in 2017-18. The middle school reported one incident as compared to six in 2017-18 and the high school reported no incidents as compared to two in 2017-18. She is recommending: 1) periodic reviews of procedures for reporting, staff training and district policies; 2) make parent training available; 3) review anti-bullying instruction to students; 4) continue collecting school-wide data; and 5) regularly analyze collected data for continuous improvement.
- c. Report on 2018-19 Seclusion and Restraint by the Director of Special Education Pat Basche The 2018-19 data on seclusion and physical restraint was presented. All incidents occurred at the elementary level and only with employees trained in either Non-Violent Crisis Intervention or Professional Crisis Management. In cases of extreme behavior, less intensive options are always utilized first. Some of the factors in reducing the number of incidents include: 1) better understanding of triggers for student upsets; 2) better communication between staff members resulting in proactive and preventative measures so escalation does not occur; 3)

better understanding of students who have experienced chronic traumatic life events and how to support the academic and social/behavioral learning for these students; 4) better understanding of mental health conditions, symptoms, and appropriate supports for affected student learning; and 5) earlier interventions for students with emotional/behavioral concerns. Director Basche reported that the District was awarded a \$30,000 School-Based Mental Health Grant. A portion of the grant will be used to increase contracted therapist hours with Family Therapy Associates. It will provide an additional day and a half of therapist time in the school buildings. This will help alleviate the current waiting list and allow therapists to work with students beyond the office into the classrooms and playground. *Exhibit 12c*
