Brief recess at 7:11 p.m. Board reconvened in the Board room at 7:14 p.m.

Jackson County Association of School Boards representative Eric Taylor reported on the February meeting, which was held in Springport. It was well attended and received compliments for the nice facilities and meal provided. Trustee Taylor reminded members that the JCASB pays for Board Members to attend CBA classes that are provided by the Michigan Association of School Board Members. The JCASB will pay for four classes per district, per year.

Treasurer Caudill gave a Finance Committee Report. The District is looking at system upgrades for the telephone system which are required by law to be made. Due to the fiscal standing for the 2016-2017 school year, this summer would be an excellent time to have them installed.

Nancy Peters Lewis, from the College Career Access Center Collaboration, reported on the services provided to area schools. The Access Center serves high school and middle school students, as well as other in the community who are looking to return to college. In addition to college services they provide information on entering the military services, apprenticeships, and direct movement into their career field. Springport High School has an advisor for 20 hours per week, from MCAM, (Michigan College Access Network), who works with students and their parents. The College Career Access Center is also helping middle school 8th graders look at their future possibilities. They take all 8th graders to visit a college campus, and Juniors are taken to skilled trades manufacturing plants and to Jackson College, Baker College and Spring Arbor College.

Dean of Students, Chris Kregel reported on the plans in progress to provide a drug summit to educate parents, students and the community on the dangers of prescription drugs. This summit is in conjunction with the Coordinated School Health and Wellness Committee. Since this is a community issue, Springport's presentation will be the first to be presented community wide.

Elementary Principal Janis Sanford reported on the science trip the fifth graders are taking to the Dahlem Center. Students will be transported daily to the Center for a week to study projects from the Next Generation Science Program. This will be done with a grant the elementary received.

Superintendent Cook presented a recommendation for Dawn Miller for part-time custodial position.

Superintendent Cook accepted the resignation of Varsity Girls Track Coach Stacy Cooper on behalf of the Board of Education.

Treasurer Caudill presented additional information on the telephone System upgrade. This upgrade is mandated as 911 calls must be identifiable from the extension from which the call is made. This makes each phone identifiable to specific classroom telephones. After initial purchase, which will place all new equipment in each room and office, the yearly savings will total about \$4000 a year.

Superintendent Cook presented an overnight request for the Cheer group to have a lock in at the school on Friday, April 21, 2017. This will be an action item on the agenda in April.

President Baglien provided the Binders to other board members for the Superintendent Evaluation. Each binder has been updated to include the job descriptions, student growth, and superintendent goals. President Baglien has reviewed the information, and is requesting each Board Committee take a section to review if there are any other artifacts they wish to insert into the evaluation. This must be done by June.
