- c. Amounts may not be transferred between funds or from any contingency appropriation within a fund.
- d. For the purpose of year-end closeout only, the Board of Education agrees to suspend the restrictions/provisions of this resolution given that a summary of all such transfers must be presented to the Board for approval no later than July 15, 2020..
