PENDER PUBLIC SCHOOL BOARD OF EDUCATION MEETING MINUTES Pender Public School – Room #207 August 28, 2018 – 7:00 a.m.

The Pender Public School Board of Education met in special session in Room 207 on Wednesday, August 28, 2019. President Peters called the meeting to order at 7:08 a.m. with the following members present: Jason Roth, Matt Peters, J.J. Maise, Jean Karlen and Mandy Johnson. Absent: Matt Heineman. Also present were Superintendent Jason Dolliver and Recording Secretary Deanna Hansen.

As required by Nebraska Statute 84-1412(8), President Peters drew the attention of those present to the location of information regarding the Open Meetings Act posted in the meeting room and accessible to all members of the public.

President Peters reviewed the agenda as presented, affirmed that all board members had received notice of the meeting and that the time and place of the special meeting had been published.

A motion was made by Johnson and seconded by Roth to approve the agenda as presented. President Peters stated the motion and the result of roll call vote being all ayes; motion carried.

A motion to approve payment of bills and budgeted transfers as follows: General Fund - \$276,169.92 and Student Fee Fund \$2,250.55 was made by Roth and seconded by Maise. President Peters stated the motion and the result of roll call vote being all ayes; motion carried.

Board Member Heineman arrived at 7:43 am.

Final valuation numbers were received on August 20th and a tentative budget for all funds was developed. The budgets of expenditure and possible tax levy were shared with members of the Finance Committee prior to the special meeting. Dr. Dolliver shared details of the proposed budgets and resulting tax levies for all funds. The total proposed tax request for all funds would be \$4,842,564.00. Board members asked questions and provided feedback. Board consensus was to consider the proposed total levy of \$.8064 after conducting public hearings prior to the regular September meeting to provide an opportunity to receive input from area patrons. Formal approval will be considered during the regular Board meeting on September 9, 2019.

Motion was made by Maise and seconded by Johnson to adjourn. President Peters stated the motion and the result of roll call vote being all ayes; the meeting was adjourned at 8:03 a.m.
