**\*Legal Memo—Section 65.90 (4)**

*Requires that "any resident or taxpayer of the governmental unit shall have an opportunity to be heard" at the budget hearing. However, in construing this statute, the Attorney General has held that the governing body cannot be compelled to make changes suggested by the citizens at the hearing on the proposed budget. The intent of the statute is to provide for an expression of public opinion but to leave the governing body free to act as it determines to be in the public interest. Accordingly, the electors at the budget hearing do not have the power to amend the budget as proposed nor to approve or disapprove such budget.*

*After and pursuant to the public hearing and prior to adoption of the board resolution finally approving the budget, the school board may, by majority vote, make such alterations in its proposed budget, if any, as are appropriate.*
