- 1.0 CALL TO ORDER @ 6.33 pm by Dr. T. Ludwick. Dr. Ludwick apologized for the small board room not having enough space for everyone.

Building sidings were repaired and painted, the campus is landscaped, and our plumbing/cooling systems all work great. Students have even commented on how good the campus looks now.

#### 4.0 PUBLIC

# Concerning Items of Interest not Addressed on the Formal Agenda:

This time is set aside at each meeting for members of the audience to speak to the Board regarding questions or issues not on the agenda. No action may be taken, but items may be placed on a future agenda.

Dr. Ludwick opens 4.0 to the public. The public was asked to give their name and they had the floor for 3 minutes. Josh Nicholson asked what the school was doing regarding school safety. Dr. Ludwick shared 50K for school safety committee twice a semester. Pick up measures w/ release of kids. Mr. Ray shared we had safety training in August.

There was a fire drill at BES on Sept. 18<sup>th</sup> and all classes lined up and evacuated, took them 12 minutes to get out on field. In November we will hold The Great California Shakeout (earthquake drill).

Brandi Gardea asked about the status of renaming of the HSMS MP room after Sheri Sonke. Dr. Ludwick shared we need to formulate a policy and put on a future agenda.

Meryl Picard – mentioned the lack of communication on Schedule – the Native Community was set back by the new time frames. In the future, if the Middle School schedule changes, it would be a hardship on them with busses and drop offs.

Shawna Bengochia shared dash board EL/Hisp/Native American students were down 60 points below standard while white students were up 10 points. What is the Board /Supt. Doing to address that? He's looking for change to make our kids successful

Mary Jane Marquez shared the BUHS student body had collected over a 125 signatures from 11<sup>th</sup> and 12<sup>th</sup> graders in support of Mr. Messih.

The Sheet Columnist, Charles James shared he had received an email from "Whistle Blower" with substantial charges against Mr. Ray regarding; undocumented students, online program and many other areas of misconduct. Dr. Ludwick referred to the letter as "disgusting, we're here to educate kids. That is slanderous and gutless. It's a distraction from our agenda, kids and education". Trina Orrill shared "every person on the board has the students and district as their priority. When they hired Supt. Mr. Jon Ray, they were meticulous and students come first. Whoever wrote that is a coward".

It took roughly three hours to hear from 46 staff members, students and community members who took the floor and had a very lengthy open session with their disappointment in the following three areas: MAP Testing, Communication and Screen Time.

#### 5.0 REPORTS AND PRESENTATIONS

Dr. Ludwick moved 5.1, 5.2 and 5.3 before 4.0 so the students giving presentations could leave and get their homework done.

## 5.1 ASB President Report – Tylar Banta

BUHS ASB Rep. Tylar reported there are 18 motivated ASB students. The Homecoming Theme this year is "Lights, Camera, and Action Hollywood Theme. October 12<sup>th</sup>, Luminary Walk; Oct 21-23 Spirt Week and the 26<sup>th</sup> is the dance.

#### 5.2 Presentation – Home Street Middle School ASB Students

HSMS ASB Reps: Karen Rivas, Shay Ludwick and Chase Gardea. The Girls reported they will be hosting 5 dances this year. They will be participating in Spirit Week in October and there theme for the week is Anti-Drugs- Colts turn up spirit. ASB has provided the entire student body at HSMS with red spirit shirts to wear on Fridays. 19/20 Theme "We're All In".

## 5.3 Presentation – Bishop Elementary School Student Council

Mr. Carr shared that the BES Student Council is made up of 4<sup>th</sup> and 5<sup>th</sup> graders. The election voting was via Chromebooks and each candidate presented a speech to their fellow peers. There were 32 funning for 4 positions.
