REQUEST TO TRANSPORT STUDENTS TO OR FROM CO-CURRICULAR ACTIVITIES

Pursuant to Midd-West School District Policy Guides #122 and #123, the District shall arrange any required transportation for students who participate in co-curricular/extra-curricular activities. When such transportation has been arranged, all participating students shall use the transportation so provided.

Transportation To and From an Activity

Provisions are available, however, to have students excused from school-provided transportation for a scheduled co-curricular/extra-curricular activity. Under the provisions, students may be excused from the provided transportation to and/or from the activity only with the permission of the coach/director responsible for the activity and only with the written permission of the parent. Such students shall be released only to the parent or guardian of the students. Parents planning to transport their child(ren) for a scheduled co-curricular/extra-curricular activity shall complete and return the top portion of the request form on the opposite side of this sheet and return this form to the coach/director in charge of the activity prior to the scheduled activity.

Release of Student to Person Other Than Parent

Students who are transported to an activity on transportation provided by the school district may be excused from school transportation for the return trip. Such students shall be released only to the parent or guardian of the students unless prior written approval is granted by the Superintendent or his designee. Parents planning to have their child(ren) released to another adult after a scheduled co-curricular/extra-curricular activity shall complete the bottom portion of the request form on the opposite side of this sheet and return this form to the coach/director in charge of the activity at least 24 hours prior to the scheduled activity. The coach/director will forward this form to the building Principal for action.

By such action above, the parent agrees to hold harmless the Midd-West School District of all liability and legal responsibility associated with the transportation as provided.
