On a Bachtell/Lemley motion and unanimous voice vote, the Board of School Directors approved PlanCon F att. C and permitted Crabtree, Rohrbaugh & Associates to submit the documents to the Pennsylvania Department of Education.

On a Lind/Bachtell motion and unanimous voice vote, the Board of School Directors permitted Crabtree, Rohrbaugh & Associates send the letter of intent to award to each prime contractor.

The Board discussed options for paying for the alternates of the Middle School project. The Board agreed the money left from the 2009 and 2012 bonds was the best option. A resolution to use the funds from the 2009 and 2012 bonds will be drafted and brought to the Board of School Directors for approval.

Discuss/Act on 2016-2017 LIU General Operating Budget

The district received the 2016-17 LIU General Operating Budget. Waynesboro Area School District's share of the budget is \$34,901.60. This is a decrease of \$549.15 or 1.55% from the 2015-16 budget. This total budget is within the 3.2% increase permitted under the Act 1 index.

On a Lind/Lemley motion and unanimous voice vote, the Board of School Directors approved the 2016-17 LIU General Operating Budget.
