The Waynesboro Area Board of School Directors held a special meeting on Tuesday, May 3, 2016, in the board room at 210 Clayton Avenue to discuss budget and textbooks. The meeting was called to order at 7:00 p.m. by President Kulla.

BUSINESS

Discuss Budget Updates

Eric Holtman, Business Administrator discussed the current status of the preliminary budget for 2016-2017 school year and shared the following information.

2016-17 Revenues: \$53,269,219 2016-17 Expenditures: (\$53,665,795)

Exp B/(W) Rev: (\$ 396,576)

From a revenue perspective, this includes a full Act 1 tax increase of 3.2% or 2.768 mills based on the April 1, 2016 Real Estate Assessed values for WASD in the amount of \$255,880,080. Additionally, it also includes an estimated increase in Pennsylvania State Basic Education Funding (BEF) of \$200,000 or 1.5% of our 2015-16 revenues. Based on historical annual increases, that is slightly less than the average increase since 2012-13.

2016-17 Budget Suggestions

Two suggestions that could bring the budget closer into alignment.

- 1. Use 95% of the Capital BlueCross premium rates for the Medical Fund. That would save approximately \$300,000 of the \$397,000 budget deficit.
- 2. Increase anticipated state revenues to 2.0% -- an increase of \$69,000 in revenue.

Medical Fund Analysis

An analysis of the medical fund was given and various scenarios were discussed.

In summary, the reserve is designed to mitigate year-over-year major variations in claims and funding levels from the general fund. It was recommended to take a multiple year approach when solving this problem. Mr. Holtzman suggested using the 95% Capital BlueCross rates for 2016-17, and plan on increasing the 2017-18 budget as well to ultimately match revenues and expenditures.

A summary of 2016-2017 Revenues and Expenditures was also provided.

Questions were asked concerning numerous line items in the expenditures summary, such as what is included in certain categories or how a projected expense was determined. Mr. Holtzman will provide the school board with information needed to answer these questions.

The administration was asked to look at possible options for increasing revenue along with decreasing expenditures.

Due to time constraints, the preliminary budget will be on the May 10, 2016 board agenda.

Discuss/Act on Textbook Adoption

Following is a list of textbooks for adoption for the 2016/2017 school year. The administration asked permission to purchase these textbooks following the two-week review period.
