As soon as feasible after all nominations are received, the Trustee will select the scholarship recipient from among the Nominees. During the selection process, the Trustee may interview some or all of the Nominees, if the Trustee believes that would aid selection. Selection will be based primarily on academic achievement. Where academic achievement alone produces no clear winner or the winner based on academic achievement has little or no financial need for the scholarship award, the Trustee will consider academic promise, financial need, and accomplishments through church, scouting or 4-H activities.

Upon selection, the Trustee will notify the recipient and the recipient's qualified college or nursing school of the award. A qualified college or nursing school is one that normally maintains a regular faculty and curriculum and normally has a regularly enrolled body of pupils or students in attendance at the place where its educational activities are regularly carried on. The Trustee will arrange to apply the scholarship award to the recipient's tuition account with the recipient's qualified college or nursing school in as many installments as possible without additional charge and will inform the college or nursing school of the criteria the recipient must meet for installments of the award to continue to be paid.

To retain the scholarship award for four years of college or nursing school and prevent it from becoming null and void the recipient must: be graduated from high school; chose and attend a qualified college or nursing school; attend the college or nursing school for consecutive years without withdrawing or being expelled; maintain a grade point average of 2.5, or average academic achievement equivalent thereto under the grading system of the college or nursing school attended; and not intentionally engage in any conduct unbecoming to a Christian in that it violates the Golden Rule or the Ten Commandments or is harmful to the recipient's Pastor.
