Motion:

That any and all bids received for the Request for Bids, Transportation of Pupils, Specifications dated March 16, 2016 be rejected in their entirety as not being in the public interest.

Motion:

That the fifth Option Year under the current contract with Tellstone & Son, Inc. be awarded at the following rates contained in their bid and subsequent contract:

Elementary Routes: \$ 195.00 per Day Secondary Routes: \$ 192.00 per Day Other Secondary Routes: \$ 239.00 per Day

Based upon our review of the routes and schedules provided, it appears that for 2016-17 the District would require the following number of routes:

Elementary Routes: 13 routes (12 for the 3 elementary schools plus 1 for the multi address students) @ \$195.00 per Route per Day (180 days) = \$456,300

Secondary Routes: 11 routes (based on actual ridership, as opposed to scheduled ridership) @ \$ 192.00 per Route per Day (180 days) = \$ 380,160

Secondary Routes: 3 Routes @ \$ 239.00 per Route per Day (180 days) = \$ 129,060

Estimated Total Cost (2016-17): \$ 965,520

**Bid Cost:

975,240+\$27,000(\$150*180 for daycare shuttle) =\$1,002,240

*Current Cost (4/5 option year with 13 elementary routes and 16 secondary routes): \$1,034,640+26,640(\$148*180 for daycare shuttle) =\$1,061,280
