AMENDMENT TO REGIONAL AGREEMENT MOTION

April 28, 2016

The following motion was made, voted, and accepted by the Blackstone-Millville Regional School Committee at the meeting of Feb. 25, 2016; to place before the member towns an amendment to the Regional Agreement to be included by the member town's Board of Selectman on the warrant for the Annual Town Meeting, in accordance with Section VI of the Regional Agreement:

A motion to amend Section XII Assumption of Jurisdiction by Member Towns over Grades Kindergarten through Five, Inclusive, by:

Deleting Sub Section (A) (B) and (C) and,

Replacing with the following language:

All students in Grades Pre-K through Five of all member towns, regardless of which member town they live in, will attend the assigned elementary school regardless of where it is located, based on grade level, beginning with the 2017-2018 school year.

And to delete Sub-Section *(A) and* (C) from Section XIII Miscellaneous Provisions.

A yes vote would allow all students in Pre-K through Grade 5, regardless of which member town they live in, to attend the assigned elementary school regardless of where it is located, based upon grade level. As an example: all PreK, Kindergarten, Grade 1 and Grade 2 at J. F. Kennedy and A. F. Maloney Elementary Schools and Grade 3, Grade 4, and Grade 5 at Millville Elementary School. It will allow the District the flexibility to deliver the most consistent and high quality education to all students.

A no vote would keep the current assignment that Millville students in K through Grade 5 would attend Millville Elementary School and Blackstone students in K through Grade 5 would attend J. F. Kennedy Elementary School and A. F. Maloney Elementary School.

Motion to amend includes the addition of Sub-section A, Section XIII to the language, "And to delete Sub Sections (A) and (C) from Section XIII Miscellaneous Provisions. This was inadvertently left off the motion voted at the 2/25 meeting but was listed correctly on the amendment that was printed in the warrant for the upcoming town meetings.
