Consent Agenda "A"

Dr. Davis added a field trip request by the class of 2014 for an overnight trip. There was some discussion and request for additional information.

Motion: It was moved by Mr. Buckley, seconded by Mrs. Robin and unanimously voted to accept Consent Agenda which includes the Warrants and the class of 2014 class trip request.

Report of the Superintendent

A, Nadine Carter, Before and After School Program - Ms. Carter presented a program and financial report on the status of the before school and after school programs. She indicated that the projection for the budget was for the program to remain in deficit by June 30, 2014. She reviewed some of the steps she has taken to increase participation and reduce costs. She gave the School Committee some ideas for expanding programs to include academic and fun activities with a participant cost. She also said that she was looking at possible summer programs.

Members of the School Committee expressed concern over the projected deficit and the need to bring the program costs in balance with fees. Several members had suggestions for how to expand the programs. Ms. Carter will report back to the School Committee by June 1, 2014 on her plans to balance expenses to revenues for the next school year.

Dr. Davis will give direction to Ms. Carter on the work she will need to do to demonstrate a balance budget for FY 15.

B. - Dr. Haughey and Dr. Davis made a presentation on the FY 15 Draft Student Services Budget. The presentation focused on the Vision and Mission of the District and how that relates to the legal requirements for special education, English language learners and homeless children. Members of the School Committee had several questions about special education expenses for out of district tuitions. Dr. Haughey indicated that he works with other area school districts and collaborative to provides services that are reasonable.

The major budget drivers are: special education personnel, tuitions, transportation, consultation, ELL staff and transportation for homeless children living in Blackstone or Millville.

Dr. Davis supported the budget proposed by Dr. Haughey and that more work will be done to review all expenses.

C. Chapter 70 and State Aid – Dr. Davis and Mr. Buckley will make a presentation to the School Committee at its meeting on February 27, 2014

D. 2014 – 2015 School Calendar – Dr. Davis presented the School Calendar for next year and he clarified the half day in November and the third Professional Development Day in January.
