**7:05 Public Forum–To Seek Community Feedback in the Identification of Educational Priorities**

President Pfarr welcomed everyone to the forum. The intent of the public forum is to get the community's input on the challenges the District faces this year and for the 2009-10 school year.

The goals hoped for is to 1) work together to ensure that the budget reductions have minimal impact on classroom learning, 2) as much as possible, to work to preserve the employment opportunities for employees and 3) make decisions that are best for students.

The Governor has mandated a budget reduction of 14.5% for the next biennium for all school districts. The actual percentage could be more than 14.5% or could be less than 14.5%. The forum will capture ideas and thoughts, which will be used for a basis to make decisions at a later date.

The group was asked to consider what the educational priorities of the community are. Once the information is gathered, the input will be analyzed and recommendations will be compiled for presentation to the Board, with the Board having the ultimate responsibility to decide what will be preserved, reduced or cut.

Mr. Jensen provided a historical review of how the District got to the point it is in now. School districts have been asked to supply a budget based on an additional 4%, 7% and 11% reduction; this equates to \$40 million, \$70 million and \$111 million across K-12 education or a \$1.2 million, \$1.5 or \$1.9 million reduction from the District's budget presented to the Board in May of 2008.

Mr. Bumgartner reported that school district superintendent's will be meeting with the Governor on December 4<sup>th</sup> and with Legislators on December 8<sup>th</sup>. A special legislative session may be held December 9<sup>th</sup>.

The audience broke into several small groups and was asked to focus on two areas; 1) what programs/positions the district should continue to fund/support and 2) what programs/positions the district should consider reducing or cutting. Ground rules were established and each group was asked to name a spokesperson to present their conclusions.

After approximately 45 minutes the groups were asked to share their thoughts and ideas. All input will be gathered from the two forums, combined on a master list and presented at the December 9<sup>th</sup> board meeting.

President Pfarr thanked everyone for coming.
