

Fitness Facility Use Agreement

_____ (Hereinafter referred to as the User(s) and the Lockwood R-1 School District (hereinafter referred to as the School), agree to allow the following described room(s) and facility(ies): Wellness and weight training facility on the high school campus to be used by the User subject to the following terms and conditions which are agreed to by the respective parties.

1. The facilities will be available from January 1 through December 31 each year during the hours of 4:00 a.m. and 11:00 p.m. All persons should be out of the facility by 11 p.m. The purpose of the facility is to be used by the user to enhance fitness and wellness of the individual or their family.
2. The User is to pay a fee at the following levels and will receive a swipe card for entry to the facility.

_____ Individual/Family Membership in District	\$50
_____ Individual/Family Membership Out of District	\$100
_____ Senior Citizen (55) In District	\$15
_____ Senior Citizen (55) Out of District	\$25
_____ Lost Card Replacement	\$15

3. The User will observe the following rules and regulations when using the facility:
 - A. For safety reasons, we recommend using a spotter when lifting weights.
 - B. Use basic good manners when using and share the equipment.
 - C. Do NOT lend your card to anyone except an immediate family member. Improper use may result in the loss of your card.
 - D. No eating or drinking except water or sports drinks in the fitness center.
 - E. Abide by all posted rules and regulations.
 - F. Treat building with respect. Close all doors and windows. Turn off lights when you are the last to leave.
 - G. Ensure that all furniture and equipment moved during use is replaced and the facility is left clean and operational.
 - H. No person under the age of 12 should use fitness equipment. No person under age of 14 is allowed to lift weights. If your child is 14-17, they must have adult supervision. All children should be supervised at all times.
4. The school reserves the right to terminate this agreement immediately by notice in writing at its absolute discretion at any time.
5. The User must give written notice to the School of any accident resulting in bodily injury or damage to property of the School or others occurring on school premises or in any way connected with the use of school premises within 24 hours of the accident. This notice must include time, place and circumstances of the incident. It should also include names and addresses of anyone witnessing the incident.

In addition, the User(s) undertakes and agrees to indemnify and hold harmless the school, school board, elected and appointed officials, administrators, principals, teachers and all other school employees, volunteers or representatives and all persons and bodies corporate acting on behalf of them, against all liability, claims, demands, actions, suits, damages, proceedings, costs and expenses whatsoever.
