Mrs. Simmons responded it's just for the mobile home. There's no land involved. Per the Tax Bureau, the mobile home is filled to the ceiling with trash and is falling apart at the seams, and the people plan to tear it

down. So, it would leave the tax rolls at the end of the year. The amount of past due taxes is \$4,282.00, and that is for 2014 on through 2018. Through 2017.

Mrs. Lauver stated question. When it says "parcel," to me that means land

Mrs. Simmons stated a mobile home is given a parcel number that is just like the landowner's one but making it separate.

Mrs. Lauver inquired so it's a rental? Parcel meant they rent?

Mrs. Simmons responded I'm assuming. I'm not sure if they rent the land or who owns it. They don't give me that information.

Mrs. Lauver inquired but they tax the mobile home?

Mrs. Simmons responded yes, it's a separate tax bill. If the landowner is one person, and the person owning the mobile home is another, there are two tax bills on that parcel, and they're given two different parcel numbers.

Mr. Musselman stated I do apologize. This isn't on the agenda. I sent out an e-mail about this. This is that rubber material we looked about putting it in there. I just need to know what you guys want to do if you want to vote on it. Like I said, an estimate is somewhere between \$5 and \$6,000.00. I don't have the exact number because I don't have the exact length of that

area. They were supposed to be measuring it today, but this would be put down and rather than grass in there or stone in there. I did get back from Keystone, and they said that they would go ahead and cut a straight line on the blacktop so it didn't look wavy going down through there, and they would put down a mat surface or whatever so no weeds would come up through, and they would bring it up to the two-inch level, and then this material would be put down rather than grass or stone or anything else. I just haven't pulled the trigger on it or moved forward with anything else because I wanted to know. It's not a big ticket item or anything, but I think it will provide. I like it better than the grass, and I like it better than the stone. Blacktop would have been great, but we got a price for that, and that just was not a go. I didn't know if you could pass them. I don't have an exact cost of it.

Mrs. Lauver inquired does it stay in place as good as well as stone would?

Mr. Musselman responded probably not. It's much lighter. Open it up, and you can see.

Mrs. Lauver inquired it won't blow?

Mr. Musselman responded it could. I don't know. It's light weight. Hopefully, it's going to compact in there a little bit, but if stone was in there and got kicked into the grass, that could start to tear your carpet. This will not. If it goes back onto the macadam, it's not as bad as stone either. If we're cutting grass, you're blowing grass one way or the other. You're going to blow it back towards the bleachers or.

Mrs. Lauver stated you could just take some kind of vacuum.

Mr. Musselman stated a leaf blower would just push them back in. That's all it would be to maintain it and, again, and that was a discussion that Chris wants to have a little bit later on. If that's your away side, there's going to be less people over there anyway, so.

Mr. Abate inquired that doesn't have the wires in it?

Mr. Musselman responded that does not. This is called playground.

Mr. Nesbit stated well, there's some cords in there, but I don't know to what level.

Mr. Musselman stated there's supposed to be no steel in it. There may be some cords, but there's not supposed to be any steel. The mulch can have actually pieces of steel in it. This you can't. That's a playground grade. The others is mulch, and that can have some steel in it because it's made from recycled tires, and if you chew on some of it, it'll last you all night long if you want to try it. It's blueberry flavored.

Mr. Sassaman inquired is that a loose product, or are we just putting down a rubber mat? I have a reason for asking that.

Mr. Nesbit inquired what's your question?

Mr. Sassaman inquired like are we going to get from that supplier?

Mr. Musselman responded yes, we're going to get from that supplier. It doesn't have to be bid out. I mean it's like I said it's a low. They're actually local in Liverpool. They're actually providing the rubber crumbs for the surface as well, so.

Mr. Sassaman stated I'll probably have to abstain if we're going to use them which is fine.

Mr. Musselman stated okay.

Mr. Sassaman stated there's nothing wrong with the product.

Mr. Musselman stated but if I can get a yay or nay from you guys to move forward with that, I'll go ahead and let people know because they'd like to get that cut and get the barrier put down, and then we will order it. We're paying for that ourselves. We're not going through the project for that.

Mrs. Lauver inquired is that? Is this all level there pretty much, or is it?

Mr. Musselman responded it does towards the down towards the softball field, it does go down a little bit. There's a little bit of grade difference, but they'll bring it up to two inches so it will be two inches the whole length.

Mr. Abate stated there's a curb there.

Mr. Musselman stated yeah, oh, yeah, there's a fence, and the wall is there is keep it on the one side. Blacktop on the other side.

Mr. Nesbit inquired and if I remember correctly, you said that you can actually push a wheelchair on that surface?

Mr. Musselman responded when I talked to them, they said that that is approved for ADA compliance. You know it's not going to be as good as a solid surface or anything else or something that's like that, but they said it does meet requirements for ADA. So, you should be able to push. Now if it's a real narrow wheel, and I think it would go down some, but a bigger outside wheelchair would probably roll over it just fine.

Mr. Nesbit inquired did they give you any requirements for a base or maximum thickness of the rubber?

Mr. Musselman responded they want two inch. If it was on a playground, they would anywhere from four to six inches. It depends on the impact area. This is just for a walking surface. They said two inches the entire length of that would be fine because it's mainly for walking or running or whatever. It's not for impact. Nobody falling, I hope.

Mrs. Lauver stated I know mulch has a tendency to nit a little bit. This in time does not. Does it ever nit a little bit?

Mr. Musselman stated I don't think. I would doubt it. There's nothing to rot or decay or anything else, too, so, there's hopefully not going to be as much as many weeds. You put mulch in there, that does rot, and you can get. At my house I get weeds on top of the barrier that I put down.

Mrs. Lauver stated mulch will hold itself together and won't blow. That's what I was wondering.

Mr. Musselman stated yeah, and when it gets wet, it absorbs. This does not absorb moisture. So, I just need to know how you guys want to do it because it's part of this project, and they need to know. They're moving forward very well on that project, and they'd like to get that knocked out as well as everything else, so.

Mrs. Lauver stated we talked about poured rubber. Is that what's at the?

Mr. Musselman inquired playground?

Mrs. Lauver inquired at Middleburg Elementary underneath the playground equipment? Is that poured?

Mr. Musselman responded uh huh.

Mrs. Lauver stated okay.

Mr. Musselman stated at the big one.

Mrs. Lauver stated that's really expensive.

Mr. Musselman stated it's very expensive. It takes a while. Dan did get a price I think for out here at West Snyder. Do you remember, Erin, how much that was? It was a big number.

Miss Sheedy responded it was a big number, and I'm holding my tongue because I don't want to undercut it.

Mrs. Lohr stated I just did a playground with that, and it was \$20,000.00.

Mr. Musselman inquired small playground?

Mrs. Lohr responded yes.

Miss Sheedy stated I'm thinking it was \$32,000.00, \$35,000.00.

Mr. Musselman stated yeah, I was thinking, yeah. I know it was a bigger number, and so, these aren't real big playgrounds either. So, it would probably be north of that.

Mrs. Lauver stated but this isn't being used like a playground.

Mr. Musselman stated no, it's not.

Mrs. Lauver stated I like the blue.

Mr. Musselman stated thank you.

Mr. Abate stated okay. So, approval is requested to purchase rubber material to be placed in the renovated field in Middleburg. Is there a motion to approve the purchase of the blue rubber material from Mahantango?

VIII. REPORTS

1. SUPERINTENDENT

Mr. Richard J. Musselman

Mr. Musselman reported on the following items:

1) Custodial/Maintenance Staff

I will say, I think, I know we hired a bunch of brand new custodians, but quite honestly, they have been doing a fabulous job. You go into the buildings, and they are looking great, and we have had a lot of things that have been repaired, little things that have been needed to be done for a long time. Our maintenance department really has gotten a lot of things finished. Kudos to Dan. There's things that we've been wanting to be fixed for quite a while, and he's arranged them, and you know, he's learning some of the business end of it, but quite honestly, he's doing a great job as far as pulling together a lot of stuff around the District. So, your support staff has really been working pretty hard over the summer, and things are looking really good.

2) High School Stadium Project - Phase I

I did want to talk about the stadium, and I don't know if we want to have that discussion you had brought up, Chris, about there was a discussion that the current home side would then become the away side as part of that second phase because the reason for that, the justification for that, is that there would be a field house that would be in the middle of that. That field house would also serve as a concession stand. It would be where the tickets. So, basically, parking and everything else would be funneled into that middle there, and those current away side of the current field we have, it would be the closest, and so the thought process is why would you have your home folks walk the furtherest distance to sit. Why would they be the home bleachers when all the new amenities and everything else are going to be right there? So, typically, you take care of your home folks, and that's one of the reasons why that was designated as the home side of the field. So, we need to know if you guys don't want to do that. We need to know because next Monday the turf is being delivered, and where they put that logo has got to be facing wherever the permanent home side is going to be. It's got to face that as well as the Mustangs on the sideline which you approved. So, I kind of need to know that like ASAP which way you want to go with that. So, I'd like to engage in some discussion if we could.

Mr. Nesbit stated the biggest concern I have about it really is the looking into the sun sitting on the other side of the field. That's really what it boils down to. Many of us have been including the staff have been to the games, and you know it's nice to have the sun at your back. While I like the having the amenities and so forth being close by, I don't necessarily want to sit there and stare into the sun. So, I don't know if anybody has had experience sitting on the other side to see just what kind of impact it has. I never really have. I'm usually. I've always sat on the home side and observed sunny

bleachers on the other side of the field. So, I just wanted to open up the dialogue and see what everybody else's thoughts were on it, and I'm open to everybody's input because it's not about me. It's about the District and the families that come to support the students.

Mrs. Lauver stated we were leaving with the parade the other evening, and as we were waiting, at one point I just said to my husband, "Talked about moving the home side to this side." We kind of glanced over, and we're looking because we were pretty high up in the truck and could see what they're doing there. I said to him, "Talked about moving the home side." Right away, he goes, "Well, that will never work because of the sun." That's exactly what he said for afternoon games and evening. Even now, you know, towards 7 o'clock, and you're getting the sun at an angle, and you don't usually get as many people at a home game from the away team normally, and just the way the stadium is set up, if it were turned differently, it wouldn't be a problem, but it's not turned, but I agree with what you're saying; the closest to the concession stand.

Mr. Musselman stated concession stand. I mean there's other restrooms that will be there. The parking. So, you know you're going to ask them to go the further side as far as the parking, but I also know, too, in like soccer and field hockey, we're a little bit different in that we actually have our parents or whoever sit on the same side as our players. A lot of times the players are on the other side of the field. So, we would look at the players still being over on that side, and obviously, they'd be over there. Now, most of that is in the fall, and, of course, the days are getting shorter and everything else. I don't know how much time is in there that that sun is at that lowest point that it's hitting you, but it doesn't. Like when you're sitting in our bleachers, it's not. You're not facing due west on that. So, I think you'd be facing so the sun would be basically like this as your looking at the field, so, as far as that goes because it's the way it's oriented. I was up there in the morning. I went up there to go up and observe what's going on just because I'm nosey and everything else. I want to see things that are happening, and if I was up there, and we had a tournament in the morning, I tell you what, it would be, if I was at the home side then, the sun is going to be my eyes. So, the sun is going to be in the eyes. Now, we don't have many tournaments, but if we did, the sun is going to be in your eyes regardless, and people can sit wherever they want to. I mean it's not as if those bleachers are going to go away or are going to be thrown away or anything else, but we were looking at those bleachers, you know, anybody that wants to go over there. There's a few people that go and sit on the other side. I mean I don't know why they do, but they do. There's some people that go over there and sit on the away side now because we have those there. So, when Jay was looking at it, he was looking at it for convenience for the people as far as coming in and how that all went together, and that makes a lot of logistical sense to do that to put those over there. It kind of brings all those services together, but I just need to know.

Mr. Abate stated when I go to the football games here (West Snyder Elementary School), I think west. So, the sun's in my eyes maybe a couple, five, ten minutes, and then it obviously moves, so.

Mr. Nesbit stated football games are usually much later.

Mr. Abate stated they start at 7:00.

Mr. Nesbit stated yeah. The field hockey/soccer, they're usually 4:00 or 4:30.

Mr. Abate stated well, that's the jv.

Mr. Nesbit stated the season is scheduled later. They're like 7:00 games now this season which is completely opposite of what it was last year.

Mr. Abate stated well, the soccer, the jv, plays at 5:30-6:00, and the varsity plays at 7:00-7:30. 7:00? I'm looking at Mrs. Folk. 7:00. So, the varsity usually there just at dusk, so. Like Mr. Musselman said, you walk in the gate. You can sit wherever you want, but if we're going to put the field house and the concession over there, then you're going to hear griping that you got to walk all the way around to get to that. I mean we're not going to please everybody.

Mr. Sassaman inquired is this an opportunity to sell Midd-West sunglasses?

Mr. Abate responded that and visors.

Laughter occurred at this time.

Mr. Abate stated I was thinking the same thing.

Mr. Musselman stated that's a great opportunity.

Mr. Musselman responded yes. That will be your main entrance area so you'll be able to go in there. The parking is going to be actually further over, and then you'll be able to go into that main area and go to the right to the old stadium or go left to the new stadium. So, yes.

Mr. Abate inquired so, did you say that the players are still going to be on the existing home side now? They're not going to move over there?

Mr. Musselman responded they may move over. I'm just saying they could stay over on that side if they wanted to, but a lot of times you go to soccer games, the players are on the other side of the field from where the fans sit. You go to even the playoffs and everything else, we're one of the few that the fans are sitting on the same side. I don't why. It's just the way we do it, and there's nothing wrong with that. It's just different. That's where the concession stand. They built the concession stand. It was all right there. You come in. You're the home. There's where you're sitting. Your bleachers are there. The concession stand, and the bathroom is here. So, it's more convenient for the home side, you know, but the carpet is coming next week.

Mr. Abate stated I think to have it centralized is okay. I mean if they want to go sit on the other side, they can. I don't want. We're not going to make everybody happy no matter what we do.

Mr. Musselman inquired do we know? Are we flipping sides or not? I mean it doesn't require.

Mr. Abate stated I'm okay with the way that it was proposed. The sun. I'll go sit on the other side. Well, I'm down on the field anyway so it doesn't matter, but when I was over.

Mr. Nesbit inquired you know what? The bottom line is you're not going to make everybody happy.

Mr. Abate stated that's exactly right. You're not.

Mr. Nesbit stated and you're right. You can go sit on the other side.

Mr. Abate stated you walk in. They're not like you got to sit where the ticket is sold. You can sit on the other side.

Mr. Musselman stated and I totally understand. If we do say, okay, the current away side is going to be the home side, and we orient the logo in the middle of the field is going to face that, and the Mustangs are going to face that, people are going to say, "What the heck is wrong with that School Board? That stupid Superintendent. They can't even put it that it's facing us." Because you know that's. You're going to hear it, and you need to look at the long-range plan. That means that that's the home side.

Mrs. Lauver stated maybe they should paint Mustangs on both sides.

Mr. Abate stated and you're going to be looking down versus up. So, we'll just charge more for the higher seats.

Mr. Sassaman stated I don't really care.

Mr. Abate stated I don't care either.

Mr. Musselman stated I don't care. I just need to know.

Mr. Abate stated I like the idea of facing each other in the middle thingy there.

Mr. Nesbit stated all right. Well, flip sides.

Mr. Abate stated flip sides.

Mr. Musselman stated okay.

Mr. Abate stated while we're on the topic of the stadium, I was just moseying around. Where the cameras, or whatever you want to call it, sit on the current away side/future home side, that platform up there up there needs some repair work. The lattice is falling out, falling apart.

Mr. Musselman stated okay. We don't want to put a whole lot in it.

Mr. Abate stated no, I get that, but you might want to just.

Mr. Musselman inquired platform?

Mr. Abate responded yeah, and are we going to power wash the bleachers this year?

Mr. Musselman responded they were. Dan, I think, has a plan. He had some folks out there. They were trying to weed underneath it and do some stuff and try to maybe even put some stone or something under the home side not the away side but put even some barrier and stone or something underneath there just because your field is going to look great, and then you're going to be sitting here, and you got weeds all underneath the seats and stuff like that. So, they were up there pulling weeds and stuff, and so, I think he's got a plan. He had said he was going to take care of that. Just, you know, he's got a little bit more time, and there's other pressing issues to take care of.

Mr. Abate stated I was just going to say the bleachers over the winter got kind of.

Mr. Musselman stated they normally spray them or pressure clean them.

Mr. Abate stated yeah, but she's probably not going to do that anymore.

Mr. Musselman stated no, but we can.

Mr. Abate inquired right, Mrs. Folk? Yeah, they're kind of filthy. That's all I have.

Mr. Nesbit inquired football games this fall?

Mr. Abate responded yeah.

Mr. Nesbit inquired are we going to play them at West Snyder?

Mr. Abate responded yeah, I'm glad you brought that up.

Mr. Musselman stated the homecoming game and then the following home game. So, the last two home games are going to be in there at Middleburg. So, I can't remember the dates off the top of my head. They are the last two in October. So, it's in October. They're going to play the homecoming game and the very last home game will be in there. What's that?

Mr. Stroup stated October 18 is the homecoming game.

Mr. Musselman stated so there.

Mr. Nesbit inquired and they're comfortable playing on that on the new field even though they play the whole season down here at West Snyder?

Mr. Musselman responded I'll say Mr. Coach Hatter has some reservations.

He would rather just stay here (West Snyder Elementary School) and play the rest of the season here (West Snyder Elementary School). I mean he expressed that. He would prefer doing that. I talked with some folks from the Boosters. Well, it's the lady who oversees the concession stand for them. It's a little bit more work to move everything up here, but the other thing, too, is that you know if you were here (West Snyder Elementary School) last year for some of their games, homecoming and some of the other ones, we didn't have parking. If we have a rainy fall like we did the last time, we destroyed these fields. We had to pay for special equipment to come in to try to flatten them out. I had. I couldn't even watch the game because I had soccer people that were yelling in my ear.

Mr. Nesbit stated yeah, I remember that.

Mr. Musselman stated because of the soccer field. We parked on it, and it's like it's not your field. It's our field. We can park where we want to, but I understand. They had stuff scheduled that they wanted to do on the soccer field. So, and the baseball field was destroyed even from practice but also from cars. So, we have a parking issue here (West Snyder Elementary School). We have a seating issue here (West Snyder Elementary School), so.

Mr. Abate stated we have a bathroom issue here (West Snyder Elementary School).

Mr. Musselman stated but the other thing is is that we're investing this money to be up there at West Snyder. They can go up there and play on that field. We don't have to worry about anything. We have the parking to do it. So, I was looking. I know Brad has expressed concern because he would just like to. He likes consistency and be able to finish out the season here (West Snyder Elementary School), but it was my call to say we're going to play the last two games here (Middleburg stadium).

Mr. Abate stated I think that's good.

Mr. Nesbit inquired could we use their middle school for?

Mr. Musselman responded yes. They would use the locker rooms in the middle school to do that. So, it is a little further away for them. For half time, they'd have to go over to the locker room and then come back over. So, yes, it is a little bit further away for two games, but they're going to play the whole next year season doing that, too.

Mr. Nesbit stated right.

Mr. Musselman stated what I like, too, is it gives us as a District to see is there anything we can do to make, you know, because not having played a football game there, and there's more cars and there's parking and everything. How is that going to be next year for the entire season of home games with the Heartland Conference which you're going to see probably more people all the time? So, it gives us an opportunity to see you know. We better address this before next season as well. So, it gives us kind of a test run to see how it's going to go as well. So, that's kind of what I was looking at.

Mr. Nesbit stated okay. Thank you.

2. **DIRECTOR OF CURRICULUM AND INSTRUCTION**

Mr. Joseph W. Stroup

Mr. Stroup reported on the following items:

1) Keystone State Results

First thing is the Keystone State results. The end of July they came out across the state, and I just have a little chart on the 2019 scores. The schools did well. As you can see, ELA we're above the state average for 2019 as we typically are. Biology made incredible gains and were well above the state average. Algebra, after two years of being above the state average, we slipped below. That's something we're going to work on to rectify. We feel that we should have above average kids, and we put in more than above average effort. So, we'll get it figured out, but Mr. Brown, Mr. Edmiston and myself, and we'll get this corrected for next year because it's something we want to address, but in general, overall, the scores for the last three years have been very good as you can see 17 through 2019.

2) SAP Liaison/Intervention Specialist Position Filled

The SAP Liaison/Intervention Specialist, the Agreement with the CMSU that you provided tonight or voted on tonight, I want to thank you for. It's a position that is going to help our students get drug and alcohol counseling from outside services or access mental health services, and the person will also be providing a lot of small group counseling to students in all four of our school buildings. So, it's a big gain for the District, and we're very hopeful that it helps our community be a healthier one, especially in the mental health area, but we're very fortunate. The girl that they found, Alexis Toburen, actually did the job for the last two years at Berwick School District and started a program similar to what we are going to have. She's been through it the last two years and will make a great addition.

3) Move-Up Day

Move-Up Day is something that our schools for the first time all did this past year, and that's where every kid actually gets their schedule and goes through their schedules before the end of the school year. We had a day and went through it. It's a way to introduce the students to what they're going to be experiencing whether it's just a new grade or a new building or a new teacher. It went so well this year. The thought of the administrative team was maybe to make it two or three days, and the reason we're considering that is there's so many things to get acclimated to to get the ball rolling for next year. We get the technology things out of the way. We start to do some team building with the new classes that they're going to be a part of, and we start to get them acclimated to the new content that they're going to be learning, and we'll keep you posted on this, but we're going to start talking with the staff at each building to see how that may work. One of the things that makes it simple is if you do it for one day, you have the schedules and everything built and in place already and with all that done, and then it's just a matter of tweaking the day and so often at the end of the year grades are due three days before the end of school. So, really they're not doing anything those last three days for credit. Why not help them get ready for

next year? That's kind of the thought process. So, that's something we'll be exploring.

4) Update on 21st Century Grant

The last thing that didn't make my agenda is the 21st Century Grant. That's a grant that we have for after-school programming for our kindergarten through seventh graders in the District. It's running in three buildings; West Snyder, ME and the middle school, and that's set to start on September 9. The IU is responsible for hiring the new employees for that, and they have their interviews set up for later this week and hopefully get the staffing for programs occurring in each of the buildings which the grant will pay for for the next five years including transportation, snacks for the kids and meals for those who attend.

Mrs. Lauver stated recently it came down that they're starting children two years earlier, required two years earlier. Will that make? Do you see any impact on our District?

Mr. Stroup responded the biggest impact it will have is our home school students because they don't have to report them until they're the age of 8 currently, and it caused a little bit of panic. The way the law was written it doesn't come into effect until September 26. That is after the home school people submit their applications to me. So, they were worried that they fell under the new law which they don't for this year. It comes into effect for them for next year, but kids that go to public school, it's going to have very little impact. We get very, very, very few students who ever wait until the age of 8 to start. So, I haven't experienced it here since I've been here.

Mr. Brown stated the other thing with the law that the way the law changed is now students are required to be in school until 18 instead of 17, so.

Mr. Stroup stated that's where we'll have the most impact.

Mr. Brown stated right.

Mr. Stroup stated students dropping out at the higher end of the spectrum.

Mr. Brown stated before this new law, at 17 students were allowed to sign, could be signed out by their parents. Now, they're required by law to be in school until they're 18.

Mrs. Lauver inquired no parent can sign them out you're saying?

Mr. Brown responded right, right. So, that is going to affect us at the high school level with the truancy.

Mr. Stroup stated before, 17-year olds, if they would just stop attending which we couldn't do anything about it. We couldn't fine them or take them to court or anything. It's just kind of they dropped from our rolls, and they were a statistic. They quit. So, now it's all the way to the age of 18.

Mr. Brown stated we would see kids roll in at noon many days out of the year, and we couldn't do anything about it. So, they would come in. If

you're not in school for ten days, you withdraw from the high school roster. So, they would come in after or on their ninth day or on their tenth day, that they'd still be a student there and do that throughout the year. So, that's going to be a big difference at the high school this year.

Mrs. Lauver stated I just. One thought I had was with some parents who felt their child was maybe not quite as mature. Now, they may. They could not choose to keep them home. They would home school I guess. Correct? That's what I was thinking, or is there a way?

Mr. Stroup responded we really want to encourage them anyway to get them in as soon as possible. We want those kids as early as possible.

Mrs. Lauver stated and that's what I was going to ask. Is there thought of a program perhaps for children that are less that needed that extra year to grow if there was a? Are schools thinking about? Not just our school. Schools in general would talk about that? Creating a readiness type?

Mr. Stroup responded we do a kindergarten screening which is readiness testing. We would have conversations with parents about that data when we place them. Ultimately, any that's of age 5 right now, we're recommending getting in here to start learning, to get exposed to the environment and language. Language is such a big part of learning, and there's studies out there that say the more vocabulary you're exposed to, the better off you'll be in the future. So, even if it's come here for kindergarten, and we consider retaining you in kindergarten again to catch you up, we'll do that, or we can make a hybrid schedule. Whatever it takes, but we want to get them in the doors as soon as possible.

3. **BUSINESS AND FISCAL**

Mrs. Amy B. Simmons

Mrs. Simmons reported on the following items:

1) Skyward Software

We've been busier than normal this summer. The Business Office has switched to Skyward. All employees including professional staff will be paid out of the new Skyward software in next week's payroll. We rolled our time tracking for timesheets, and I'm just finishing the step-by-step guide for time off and should be able to roll that out tomorrow. It's been a long process, but we're getting there, and we have, as of this morning, all glitches out of the timesheets. So, we're hoping everything goes smoothly with the time off getting rolled out this week.

2) Local Audit

Auditors should be in contact with me the next week or so. Krista, they're planning on coming in in September, and that's about it. It's just been really busy getting the new software out and year end, and tax season is starting.

Wanted to let you know that our new special education secretary, Tiffany Summers, started last Monday and appreciate being able to get her in and get her started before the school year begins, and I would just add that I think our two new special education teachers are going to be fantastic, and I can't wait to see them dive in this year.

Mr. Abate inquired, Mrs. Bzdil, your Work Study Program, how did that end?

Mrs. Bzdil responded successfully.

Mr. Abate inquired did it?

Mrs. Bzdil stated I mean yeah.

Mr. Abate inquired I mean how many students did we?

Mrs. Bzdil responded we have, do I want to say, five of the students from last year are going to SUN Tech this year with some job soft job skills and hopefully at a point with their social/emotional skills and things that they'll be successful over there and be able to graduate and obtain employment. have a few Life Skills type students entering the School-to-Work Program. So, we are pulling one of the paraprofessionals from the Life Skills Program to further support in the School-to-Work Program. We're going to have a student actually working at Rayauda's this school year with a Job Coach with her. So, we'd really like to expand those types of opportunities in the community.

Mrs. Bzdil responded oh, gosh. I'm trying to.

So, she deserves a lot of credit for the good things that are going on and that group of kids. Also, Mrs./Dr. Spangler who runs are regular Work Study Program would like to come in at some point and talk about all the good things that are happening in the Work Study Program as well. So, this year at some point, we'd like her to come in and just kind of share some of that stuff with you folks.

Mr. Abate stated set that up with Mr. Musselman.

Mr. Brown stated yep. The summer help we had this year was fantastic. It was kind of flawless this summer. They did a wonderful job. Most of them, well, quite a few of them were back from last year so they knew what needed done and did it kind of without being told to do it. So, thank you for voting for those students to do that program. The new custodians, also as mentioned, our custodians that we have that jumped on board, fantastic. So, we may have mentioned what looks like a coal bed in front of the building. It is rubber mulch, and it looks great out there. We had a problem with dirt splattering up on the building, and Mr. Musselman helped us fix that. We had rubber mulch put out there to make that, to dress that up a little bit better, and it looks great. And, just lastly, new members of our team, they're ready to get started. They're excited, and they're ready to jump in. So, that's good to see as well.

Mr. Nesbit inquired Back-to-School night Thursday at 6:00?

Mr. Brown responded 6:00 to 7:30 at the high school, yeah.

Mr. Aucker stated my Back-to-School night is 6:30 to 8:00, and I wanted to have that half-hour gap in case of having some high school parents who would want to do both places. Our school is ready to go. I am very happy in reporting that our custodial crew has made our school look the best it has ever been. They cleaned from top to bottom, and we worked through a very tumultuous year last year, and we have reaped the benefits. I can just say that, and kudos to the crew. They worked their tails off. It looks great. So, ready to go. We're excited.

Miss Sheedy stated looking forward to meeting our students on Wednesday evening for Kindergarten Orientation at 5:30 and Back-to-School night for first through fifth grade starts at 6:15. So, really excited to see the new kindergarteners and greet our returning students after the summer and quick question. Student for the next Board meeting, correct?

Mr. Abate responded yeah, yes, the 26th, which reminds me. Mr. Brown, are you going to have our student representatives? You or Mr. Edmiston?

Mr. Brown responded yes.

Mr. Abate inquired we'll have a senior and a junior this year?

Mr. Brown responded yep.

Mrs. Lohr stated the building is ready to go. We just had the step removed and replacement is a ramp. It's going to hopefully prevent a lot of people from tripping and falling from my understanding. So, that is ready to go. It's in good shape. Beautiful.

Mr. Abate inquired Back-to-School night tomorrow night?
