2nd Annual River Hawk Girls Basketball Tournament

- Divisions:** 4th, 5th, 6th, 7th and 8th Grades – Girls
- Date:** Saturday, February 8th and Sunday February 9^h, 2019
- Locations:** Easton Valley High School, 321 West School Street
- Entry Fee:** \$130.00 – Entry deadline is February 3rd 2019. Entries will be accepted in the order received. A team will be officially entered upon receipt of a registration form and check.
- Admission:** \$5.00 per adult and \$3.00 per student. Players and two coaches will be admitted free.
- Format:** 6 teams in each division; round robin. First and second place determined by head to head record then by total defensive points allowed, if needed.
- Eligibility:** All players on the team must go to the same school. A lower grade player may play in a higher- grade division but may play only on one team. No all-star teams will be accepted.
- Equipment:** Bring your own warm-up balls. Teams must have light and dark jerseys with numbers on the back. 28.5 “women’s ball will be used for all divisions.
- Awards:** Up to 10 medals per division will be awarded to the first and second place teams.
- Rules:** See attached.
- Concessions:** A complete concession stand will be available at both schools provided by the Easton Valley Athletic Boosters.
- Waiver:** The Easton Valley Athletic Boosters sponsor this tournament. The enclosed waiver is mandatory for each player and must be provided at check-in prior to the first game.

Easton Valley Athletic Boosters
2nd Annual River Hawk Girls Basketball Tournament
Rules Apply to All Divisions

1. Iowa High School Rules will apply with the following exceptions.
2. All players must have a light and dark team jersey with numbers on the back.
3. Games will begin with a jump ball.
4. Games will consist of two **sixteen-minute** halves with three-minute halftimes.
5. The clock will run continuously except for the following: timeouts, injuries, the last minute of each half and overtimes.
6. Timeouts are one-minute long. Each team will receive two timeouts per half and one timeout per overtime. Timeouts cannot be carried over from the first half to the second half or from the second half to overtime.
7. Teams may press until they have a 20 point or more lead.
8. 3-point goals will count in all divisions if the floor is marked.
9. Fouls:
 - * Bonus free throws will be one and one on the seventh team foul and two shots on the tenth team foul.
 - * Technical foul will be an automatic two points and possession of the ball.
10. First overtime – 1 minute off of a jump ball and clock stops; second overtime – off of jump ball sudden death, first point wins.
11. All substitutes must report to the scorer's table.
12. Game time is forfeit time.
13. No protest – all calls of the officials are final.
14. Coaches are responsible for the conduct of their players and fans. Unsportsmanlike conduct will not be tolerated.
15. All teams will be asked to provide a scorekeeper for at least one game.
16. 28.5-inch basketball will be used for all games.
17. Zone defense will be allowed in ALL DIVISIONS

Locker rooms will not be available. Neither the Easton Valley Community School District nor the Easton Valley Athletic Boosters will be responsible for lost, stolen or damaged property.
