The old handbook listed all the sports and the requirements in order to achieve a letter, and after each, stated "and at the coach's discretion." We wanted to give kids more letters and the benefit of the doubt. "Kids First" is our motto and our athletes will earn a letter if they do what is expected. Dr. Disney recommended the board approve the revised athletic handbook. Mrs. Trezak moved to approve the handbook, Mr. Mefford seconded, and the motion carried.

5.0 Other Business Items/Curriculum & Instruction

5.01 Consideration to approve overnight trip to Camp Tecumseh – October 1 & 2, 2015 – Dr. Disney said a lot of planning goes into this long-standing tradition and it's a great opportunity for kids. Mr. Halcomb moved to approve the overnight trip to Camp Tecumseh and Mrs. Trezak seconded. Mr. Gilliana said that every year some comes to a board meeting and says to him please don't take camp away from our kids. We've always promised to continue with this tradition. Mrs. Trezak said this is an environmental camp that teaches our kids a lot and it brings the students together from

the two elementary buildings to get to know each other. Dr. Disney extended an invitation to the board to travel down to the camp for a day or even for the night. The motion carried.

6.0 __Informational Agenda Items_

- 6.01 Board Communication Dr. Disney said he had no communications for the board other than information received about the ISBA Superintendents/Board Fall Conference at the end of this month.
- 6.02 Superintendent/Building Reports – Dr. Disney thanked Kevin Trezak and his staff members for hosting the board meeting tonight. Mr. Trezak talked about all the planning that's gone into this school year. We've faced yet another transition, but it was planned right this time. Meister has grown by approximately 120 students. Now Meister is the same size as Evans. At last count, Meister had 359 students and Evans had 358. We have new teachers, paraprofessionals, benchmark testing, and new technology. Three major things were done in planning this transition. In April there were meetings with parents and the community; students came over from Evans and were shown around the school; and there was an evening question and answer meeting. Clearly communication was a big part of the success of this transition. He said this was a challenge and was done in a way to take care of the needs of our children. Dr. Disney recalled last fall when Mr. Kissel and Ms. Whitt both told him they wanted to see some changes. This was a tremendous change. Everybody came on board to do what's right for kids. Dr. Disney thanked the staff, teachers, principals and school board. He also announced that this is Homecoming Week at the high school and encouraged everyone to come out and support the Ingots.
- 6.03 Adjournment There being no further business to come before the board, Mrs. Martin moved to adjourn and Mr. Halcomb seconded. The motion carried and the meeting adjourned at 7:25 p.m.
