

REGULAR TEACHER CONTRACT

- ❖ Prescribed pursuant to Ind. Code 20-28-6-3 as the regular and uniform contract
- ❖ for the employment of teachers pursuant to Ind. Code 20-28-6-4(b)

This regular teacher contract ("Contract") is by and between the governing body of the Randolph Central School Corporation ("Corporation") and Julie R. Northcutt ("Teacher"). Julie R. Northcutt is a teacher as defined in Ind. Code 20-18-2-22.

In exchange for the Teacher's services described below, the Corporation and the Teacher agree that:

1. The Teacher shall teach in the schools of the Corporation for the school term, beginning July 1, 2022 and ending on June 30, 2024. Ind. Code 20-28-6-2(a)(3)(A)
2. The school term described in paragraph 1 immediately above for services under this Contract consists of 240 days per school year. Ind. Code 20-28-6-2(a)(3)(B)
3. The number of hours per day the Teacher is expected to work under this Contract is 8. Ind. Code 20-28-6-2(a)(3)(E)
4. The Corporation shall pay the Teacher for services under this Contract the total salary of \$100,823.06 during the school year. Ind. Code 20-28-6-2(a)(3)(C)
5. The Corporation shall pay this amount in 24 installments on a twice a month basis. Ind. Code 20-28-6-2(a)(3)(D) Ind. Code 20-28-6-5(1)
6. This Contract may be cancelled during its term for any of the grounds set forth in Ind. Code 20-28-7.5-1(b) pursuant to the procedures set forth in Ind. Code 20-28-7.5-2 and Ind. Code 20-28-7.5-3.
7. This Contract is a public record pursuant to Ind. Code 20-28-6-2(d) and Ind. Code 5-14-3.

EXHIBIT "A"

ADDITIONAL TERMS AND CONDITIONS OF ASSISTANT SUPERINTENDENT FOR CURRICULUM & INSTRUCTION CONTRACT

- 1. Payment by Randolph Central School Corporation toward \$60,000 Life Insurance Policy all but \$1.00 of the annual premium.**
- 2. Payment by Randolph Central School Corporation toward Health and Hospitalization all but \$1.00 of the annual premium for North Central Indiana School Insurance Trust Plan 3 or 4 only. Should the administrator choose Plan 1 or Plan 2, he/she will pay the difference in premium.**
- 3. The Board shall pay a stipend of \$6,000 to any administrator taking North Central Indiana School Insurance Trust Plan 3 or Plan 4. The amount of this stipend is not guaranteed in future contracts.**
- 4. If the administrator, chooses NOT to elect any Health and Hospitalization mentioned in part 2 and therefore is not eligible for the \$6,000 stipend mentioned in part 3, then the Board shall pay a stipend of \$8,000 to that administrator. This stipend will be paid over 24 pay dates. If the administrator's household experiences a life changing event, according to NCISIT rules, that makes him or her eligible to begin insurance coverage and elects to do so, the \$8,000 stipend will be terminated effective the day insurance coverage begins.**
- 5. Payment by Randolph Central School Corporation toward Long-Term Disability Insurance all but \$1.00 of the annual premium.**
- 6. Mileage and expenses as approved by the Board.**
- 7. Ten (10) sick leave days per year. The number of day's sick leave will be capped at 90 days. The Board will allow up to 90 sick days to be transferred from the previous employer immediately upon hire.**
- 8. Payment by Randolph Central School Corporation toward the Assistant Superintendent for Curriculum & Instruction's total contribution of three (3) per cent to the Indiana State Teacher Retirement Fund**
- 9. Paid holidays will be as follows:**

New Year's Day	If January 1 falls on a weekend, administration will determine the day off.
-----------------------	--

Good Friday	If school is not in session. If school is in session, one day off with pay will be given on the Friday of Spring Vacation.
--------------------	---

Independence Day If July 4th falls on a Saturday, the preceding Friday will be granted off with pay, if on a Sunday, the following Monday will be granted off with pay.

Memorial Day

Labor Day

Thanksgiving Day and the Following Friday

Christmas Eve and Christmas Day December 24th and 25th will be paid holidays. If either falls on a weekend, the administration will determine the day(s) off.

New Year's Eve One-half day off with pay. If December 31 falls on a weekend, the administration will determine the (1/2) day off.

10. **Working Days of the Assistant Superintendent for Curriculum & Instruction:**
The contract shall consist of 240 days. The 240 days shall include 235 working days, plus five (5) vacation days.
11. **The Board agrees to provide a cellular telephone with data capability to the Assistant Superintendent for Curriculum & Instruction.**
12. **The Assistant Superintendent for Curriculum & Instruction agrees to perform at a professional level of competency as required by contract, state law, and the policies of the school board as they may be modified or changed from time to time.**
13. **The following portions of the Master Contract between the Board of School Trustees Education and the Randolph Central Classroom Teachers Association also apply to Administrators:**

Article V - Paragraphs (B) (C) (D) (E) (F) (G) & (H) or (I)

Article VI- If otherwise qualified

Article VII

Article VIII

14. **The Board shall contribute \$3,000 annually to a qualified retirement plan permitted by the school, such as a 403(b) plan. To the degree permitted by law, this contribution shall count as income for purposes of the Indiana Teacher's Retirement Fund.**




