School districts are required by law to mail this information to all voters of the District after the date of the Budget Hearing on May 3, 2016 but no later than six days prior to the budget vote and election.

The annual Budget Vote for the fiscal year 2016-17 by the qualified voters of the Greenville Central School District, Greene County, New York, will be held at the Greenville Elementary School in said district on Tuesday, May 17, 2016 between the hours of 1:00pm and 9:00pm, prevailing time, at which time the polls will be open to vote by voting ballot or machine.

*Under NYS law, a school may submit a budget to voters a maximum of two times. If the budget is defeated the Board may adopt a contingent budget or put a budget before the voters a second time. If the budget is defeated twice, the Board must adopt a contingent budget. Certain existing contingent budget requirements remain in effect that prohibit spending in specific areas including community use of buildings, certain salary increases and new equipment purchases. More significantly a district that adopts a contingent budget may not increase its current tax levy by any amount. Using the required formula the proposed budget is below the allowable tax levy limit, and requires a simple majority. The proposed tax levy increase under the proposed budget is \$159,939.
