#### CALL REGULAR BOARD MEETING TO ORDER AND ROLL CALL

Principal McDonald.

#### SUPERINTENDENT'S REPORT

For Fiscal Year 2018 ending on June 30, I have provided you the most recent update on school finances. The State still owes the District \$121,460.66 for last year, which can be found in MCAT payments for some special education, Driver's Education, Transportation, Early Childhood, the Ag Incentive Grant, and the Healthy Communities Grant. We ended the year expending 96% of our original budgeted amounts. For FY 19, we have not received any word on the new GSA numbers for this year or any state grants. We did file our Title Federal grants this past week. Even though a budget was approved and signed by the Governor, ISBE still has not released any new numbers for this new school year.

Normal building projects are going well. The windows and doors at North School are scheduled around the 1<sup>st</sup> week of August. The boiler will likely be installed around the 2<sup>nd</sup> week of August. New floor installed in HS office and painted by the custodial crew – teacher's lounge is next. For the North School water issue – the Engineers have put a camera and smoke down the pipes and not having much luck. We dug up an old brick structure they found between the old and new editions and found very little. In fact, most of the pipes in there had been sealed off. Starting next week, we will start digging around the building to find the clay tiles or if any drainage still exist under or

around the building. It is likely that we will have excavate around the entire building to lay a new tile and drain it to a storm drain somewhere nearby. If we have to open the entire area up, they will fix the walls by seal coating them before filling back in.

I received an email indicating that a group of citizens (mostly from Hillsboro and Litchfield) have organized a committee to explore a county-wide consolidation study. The Montgomery County Board has given them \$10,000 to begin the study with additional donations from individuals, foundations, and companies. Dr. Doerr stated that even though he spoke to a committee member a few months ago, someone from the committee will be at a future Board meeting to discuss. Dr. Doerr recommended not taking part in the study and without a formal vote, the Board verbally agreed.
