Roll call was held with the following members present: Rex Arkebauer, Lenny Monroe, Mike Schurman, Phil Watson and Steve Phillips.

The meeting opened with the Pledge of Allegiance.

Mr. Arnold spoke to the Board regarding his concerns for the low number of students who have expressed interest in playing basketball in the upcoming year. Mr. Arnold expressed interest in cooping basketball with Athens.

Mrs. Newbold presented the itinerary for the senior trip that will be taken on May 27, 2015 to Chicago.

Erik Raikes gave an update on the athletic programs.

The Consent Agenda consisting of the minutes of the April 16, 2015 regular meeting, April 23, 2015 Sine Die Meeting, April 23, 2015 Special Meeting, April 30, 2015 Special Meeting, April Imprest Fund, Treasurer's Report, Investment Reports, Student Activity, and May bills were presented. An addition to the agenda was added to include #17) Senior Trip and #18) Eighth grade trip. Schurman moved to accept the consent agenda. Watson seconded the motion and it carried unanimously by roll call vote.

Schurman made a motion to approve the minutes of Closed Session. Watson seconded the motion and it carried unanimously by voice vote.

The FFA ended the year with another outstanding banquet. We are proud to have such a wonderful and active chapter.

Junior High Track had seven State Qualifiers this year.

The spring music concert was very good and a thank you to our music teachers.

Prom was well attended and decorations were outstanding once again.

The District has six students of the class of 2016 expressing interest in taking L-Tech courses next fall. L-Tech is held in Lincoln so that scheduling and availability for students will need to be researched. The cost to the district will be \$750 per student per semester.

Superintendent Kunz provided updates on insurance costs, Co-op with Athens, and negotiations:

- The insurance cost for workman's comp will increase by 10% to \$28,929 due to two current claims that are open and the property/casual will increase by 3% to \$18,416. Part of the increase is the addition of Cyber/Identity Theft Coverage as a mandated line of coverage in the program.
- Co-op with Athens has been approved by the Athens Board except for High School girls' basketball.
- Contract Negotiations with the GEO made some changes to the contract but the focus was the salary schedule.

Superintendent Kunz provided the board members with the DCFS Mandated Reporter paper work to be completed by each board member.

Superintendent Kunz noted that the amended budget was complete and has been on file since May 18, 2015 for public viewing. The Board received summary pages of the amended budget for review.

Superintendent Kunz gave the board a copy of the Greenview Awareness Initiative brochure.

Superintendent Kunz reviewed the fees for the 2015-2016 school year with only two changes recommended. Those changes a science fee of \$5 for grades 6-12 and an increase of the student lunch charge to \$2.25 for 6th. grade.

Superintendent Kunz noted that the lighting grant for the replacement of the gym lights reads that the grantee will pay based on the number of annual kilowatt hours of electricity reduced as a result of the project. The cost will not be more than \$18,025 or 40% of the total resulting cost of the project. The district will pay from \$4,000 to \$13,000 of the \$22,000. This project will help by cutting utility cost as well as contributing 40% of the project cost.

Watson made a motion to approve the soccer, baseball, and softball co-op teams with Athens for 2016-2018. Arkebauer seconded the motion and it carried unanimously by roll call vote.

Watson made a motion to approve the two year Greenview Educational Organization contract as presented for 2015-2016 and 2016-2017. Schurman seconded the motion and it carried unanimously by roll call vote.

Monroe made a motion to approve the renewal of IHSA participation for 2015-2016. Schurman seconded the motion and it carried unanimously by voice vote.

Arkebauer made a motion to approve the renewal of IESA participation for 2015-2016. Monroe seconded the motion and it carried unanimously by roll call vote.

Schurman made a motion to accept the resignations of Jennifer Schurman as Jr. High Volleyball Assistant, Aaron Janessen as Jr. High Boys Basketball Coach, Katie Peters as HS Cheerleading Coach, and Erick Raikes as HS PE teacher, Athletic Director and HS Varsity Basketball Coach. Watson seconded the motion and it carried unanimously by roll call vote with regrets for Mr. Raikes departure.

Schurman made a motion to accept the hiring of Ashley Constant as Jr. High Volleyball Assistant. Watson seconded the motion and it carried unanimously by roll call vote.

Arkebauer made a motion to approve the hosting of Greenview Golf Regionals at Country Hills Golf Course on October 6, 2015. Monroe seconded the motion and it carried unanimously by roll call vote.

Schurman made a motion to approve the amended school calendar for 2014-2015 with the last day of attendance for students to be June 2, 2015 and a Teachers Institute to be held on June 3, 2015. Watson seconded the motion and it carried unanimously by voice vote.

Monroe made a motion to approve the hiring of all non-certified personnel as presented. Watson seconded the motion and it carried unanimously by roll call vote.

Watson made a motion to approve 2% raises for the non-certified personnel as presented for 2015-2016. Schurman seconded the motion and it carried unanimously by roll call vote.

Phillips made a motion to approve 2.5% raises for the administration as presented for 2015-2016. Schurman seconded the motion and it carried unanimously by roll call vote.

Watson made a motion to approve the registration fee schedule for 2015-2016 with an addition of a \$5 science fee for student in grades 6-12 as presented. Monroe seconded the motion and it carried unanimously by roll call vote.

Watson made a motion to approve the lunch/milk fees with the cost for 6th. grade lunch to be changed to \$2.25 for the 2015-2016 school year, Schurman seconded the motion and it carried unanimously by roll call vote.

Watson made a motion to approve the lighting project for both gyms at a cost of \$13,200. Monroe seconded the motion and it carried unanimously by roll call vote.

Watson made a motion to hire Preston Green and Anthony McCoy as summer employees at minimum wage for four weeks. Monroe seconded the motion and it carried unanimously by roll call vote.

Watson made a motion to approve the senior trip to Chicago as presented. Monroe seconded the motion and it carried unanimously by voice vote.

Watson made a motion to approve the Eighth grade/Honors trip to St. Louis. Monroe seconded the motion and it carried unanimously by voice vote.
