# PHS CONSTRUCTION UPDATE

Construction bids will be taken as soon as final approval is received from the Arkansas Division of Public School Academic Facilities and Transportation. While waiting on final approval, PSD may request to be given permission to order the reinforcing steel and have it onsite, which will help the timeline of the project by a few weeks. Motion was made by Josh Honeycutt and seconded by Teresa Hill to approve making a request from the Arkansas Division of Public School Academic Facilities and Transportation to allow the reinforcing steel to be ordered prior to final building approval. # **BIKING/WALKING TRAIL EASEMENT**

The trail will begin in the Sundale area near the Rotary Softball park and will follow 8 mile creek, on its east side. The trail will then cross PSD property as it follows the creek.
