- B. Brief opening statement, if any, by the Superintendent as to the evidence to be presented.
 - C. Brief opening statement, if any, by the Principal as to the evidence to be presented.
- D. Presentation of witnesses/evidence by the Superintendent in support of the dismissal recommendation, followed by any cross-examination by Principal of any witness called by the Superintendent regarding the statements made by the witness, and any questions by board members of any witness called by the Superintendent.
- E. Presentation by Principal of witnesses/evidence opposing the recommendation, followed by any cross-examination by Superintendent of any witness presented by the Principal.

regarding the statements made by the witness, and any questions by board members of any witnesses presented by the Principal.

- F. Presentation by Superintendent of rebuttal evidence, if any, that being evidence in response to the evidence presented by the Principal. If there is no rebuttal evidence to be presented by the Superintendent, then the hearing will proceed to hem 1.
- G. If any rebuttal evidence is presented by the Superintendent, then cross-examination by the Principal of any such rebuttal witness regarding the statements made by the witness, followed by questions by board members of the witness.
- H. If any rebuttal evidence is presented by the Superintendent, then presentation by Principal of evidence in response to the Superintendent's rebuttal evidence regarding the statements made by the witness. followed by cross-examination by the Superintendent of such witnesses, and questions by board members of any such witnesses.
- I. Closing comments/arguments by the Principal and presentation of any proposed Findings of Fact for the board to consider in executive session.
- J. Closing comments/arguments by the Superintendent and presentation of any proposed Findings of Fact for the board to consider in executive session.
- K. Discussion and vote to convene into executive session, pursuant to 25 Oklahoma Statutes Section 307(B)(1), so that the board can discuss the evidence presented in the hearing and return to open session to vote to adopt Findings of Fact and vote to dismiss or not to dismiss Myra Hamin based upon the adopted Findings of Fact.
