November is Native American Heritage Month, the Student's shared Traditional Dancing early today in the BAC for their classmates, teachers and staff.
 - 5.5.2 TiAna Vargas, Home Street Middle School Ti'Ana presented with her newborn daughter the Native American Data from HSMS, this included enrollment by grade level, ELA & Math CAASPP 18/19 results along with MAP Fall Data.
