Bids will be accepted for furnishing bread products to Wynne Public Schools during the 2023 -2024 school year as specified below until **2:00 p.m. June 9, 2023.** Bids will be awarded at the next local board of education meeting on Monday, June 19, 2023. All bids shall be submitted on this prepared proposal blank and addressed to: Wynne Public School, Attn: Sherry Jumper, PO Box 69, Wynne AR 72396, delivered in person, or emailed to sjumper@wynneschools.org. All bidders shall comply with the Department of Health Rules & Regulations relative to bakeries and baking products. All breads must be <u>fresh</u> and in <u>good condition</u>. <u>Please</u> note whole grain-rich products must be **certified** whole grain rich. Whole must be the first ingredient or the "gold" seal must be on packaging. All other breads must be enriched flour. <u>A product analysis on each product or if your company has a Child Nutrition statement for the weights and grains it must be included in bid packet. <u>Products that are awarded MUST be what is delivered for service</u>.</u>

Buy American: SFA by participating in the federal school meal programs is required to purchase domestic commodities and products for school meals to the maximum extent practicable. Domestic commodity or product means an agricultural commodity that is produced in the U.S. and a food product that is processed in the U.S. substantially (at least 51 percent) using agricultural commodities that are produced in the U.S. (7CFR210.21, 220.16). Selected Distributor must be able to comply with this requirement. Federal regulations require SFAs to take all necessary affirmative steps, when possible, to assure that small, minority, and women-owned business enterprises are used (2 CFR Part 200.321).

DELIVERY:

Time and day of delivery are to be worked out with the successful bidder and the purchaser. Deliveries include Wynne Primary, Wynne Intermediate, Wynne Junior High, Wynne High School. This will be a total of 4 campuses. Deliveries cannot be made for the following week, with Monday being the only exception. Deliveries will be made as key drops at each location. It is to be understood by each bidder that deliveries will be discontinued during regular school vacation periods, also in cases where schools are closed due to inclement weather. A delivery slip shall be left at each school showing amount of bread purchased on the day of delivery. This request will be divided into two categories. White Whole Grain and Enriched Flour products. It is expected that all campuses will be delivered the same product district wide, when ordered.

BILLS:

Monthly statements for each school must be sent to Wynne Schools Child Nutrition Director, PO Box 69, Wynne, AR 72396 or emailed to sjumper@wynneschools.org before the 10th of each month for preceding month's deliveries.

RESERVATION & TERMINATION:

The Board of Education reserves the right in its absolute discretion to accept any bid, or any part of any bid, or to reject any or all bids, or any part of any bid, as the Board deems it to be for the best interests of the Board. The Board further reserves the right to terminate the contract at any time for due causes which shall include such reasons as unsatisfactory service or unsatisfactory products. Supplier may also terminate the contract with a 30 day written notice. Bids will be awarded based on low price and past performance.

TERMINATION: The Board of Education reserves the right in its absolute discretion to accept any bid, or any part of any bid, or to reject any or all bids, or any part of any bid, as the board deems it to be in the best interest of the board. In the event of a tie bid all bids will be considered void and will be rejected. Bid will be awarded based on lowest price and past performance. Award criteria: (1.Price 40 pts. 2. Quality 30 pts 3. Service/Performance 20 pts. 4. Availability 10 pts).

Termination for Convenience: The board further reserves the right to terminate the contract at any time for due cause/convenience, which shall include such reasons as unsatisfactory products or service. Supplier may also terminate the contract with a 30 day written notice. Termination of contract for any reason, by either party will include: District pay all invoices due for services that have been completed, Company will pick up milk boxes if applicable, and return all keys upon pickup. Upon such termination, the Contractor shall have no right to any actual general, special, incidental, consequential, or any other damages whatsoever or any description or amount.

Termination for Cause: If the Contractor fails to properly perform its obligations under this contract in a timely or proper manner, or if the Contractor violates any terms of this contract, the School District shall have the right to terminate the contract and withhold payments in excess of fair compensation for the completed services.

- A. The School district will provide notification of termination for cause in writing. This notice will: (1) specify in reasonable detail the nature of the breach. (2) provide the Contractor with an opportunity to cure, which must be requested in writing no less than 10 days from the date of the Termination Notice, and (3) shall specify the effective date of termination in the event the Contractor fails to correct the breach. The Contractor must present the school district with a written request detailing the efforts it will take to resolve the problem and the time period for such resolution. This opportunity to "cure" shall not apply to circumstances in which the Contractor intentionally withholds its services or otherwise refuses to perform. The School District will not consider a request to cure contract performance where there have been repeated problems with respect to identical or similar issues, or if a cure period would cause a delay that would impair the effectiveness of School District operations. In circumstances where an opportunity to cure is not available, termination will be effective immediately.
- B. Notwithstanding the foregoing, the contractor shall not be relieved of liability to the School District for damages sustained by virtue of any breach of this Contract by the Contractor.

BREACH: A party shall be deemed to have breached the contract if any of the following occurs:

- A. Failure to perform in accordance with any term or provision of the contract.
- B. Partial performance of any term or provision of the contract
- C. Any act prohibited or restricted by the contract, or
- D. Violation of any warranty

CONTRACTOR BREACH: The School District shall notify the Contractor in writing of a breach.

- A. In event of a breach by Contractor, the School District shall have available the remedy of actual damages and any other remedy available at law or equity.
- B. In the event of a breach, the School District may assess liquidated damages.

Partial Default: In the event of a breach, the School District may declare a partial default.

CONTRACT TERMINATION: In the event of a breach, the School District may terminate the contract immediately or in stages. The Contractor shall be notified of the termination in writing by the School District. Said notice may specify either that the termination is to be effective immediately, on the date certain in the future, or that the contractor shall cease operations under this contract in stages. In the event of a termination, the School District may withhold any amounts which may be due the Contractor without waiver of any other remedy or damages available to the School District at law or equity.

SCHOOL DISTRICT BREACH: In the event of a breach by the School District, the Contractor shall notify the School District in writing within 30 days of any breach of contract by the School District. Said notice shall contain a description of the breach. Failure by the Contractor to provide said written notice shall operate as an absolute waiver by the Contractor of the School Districts breach. In no event shall any breach on the part of the School District excuse the Contractor from full performance under this contract. In the event of a breach by a the School District, the Contractor may avail itself of any remedy at law in the forum with appropriate jurisdiction, provided, however, failure by the contractor to give the School District written notice and opportunity to cure as described herein operates as a waiver of the School District's breach. Failure by the Contractor to file a claim before the appropriate

forum in Arkansas with jurisdiction to hear such a claim wihin one (1) year of the written notice of breach shall operate as a waiver of said claim in its entirety. It is agreed by the parties that this provision establishes a contractual period of limitations for any claim brought by the Contractor.
