Looking at other options to increase revenue

New MS Construction Fund - continuing to earn \$9,000/month in interest on bond

Board Study

- A) Promise Scholarship Defer to October board meeting Discussion -
 - ° Board preferred to discuss, not defer to October
 - ° Continuation of scholarship on an annual basis if so, set up criteria for scholarship(s)
 - ° Not a hardship to continue if dollars are in the budget
 - ° Good thing to continue
 - ° Enrollment for 2017-2018 is up, State School Fund should come in higher
 - ° Establish criteria for students who want to teach and return to Nyssa after college, hard to find teachers
 - ° Need staff more representative of the student body
 - ° Determine where dollars are coming from in the budget
 - ° Based budget with \$5,000, not confirmed
 - ° Present a resolution for unappropriated, create line item for board approval
 - ° Do not give scholarships for 2017-2018, plan for it February 2018 in anticipation for 2018-2019

Concerns -

o If criteria is added for students wanting to teach and return to Nyssa, all students applying would check or indicate this on their application

Recommendation -

- ° Continue board scholarship this year
- Opennis Savage and Lucy Beck volunteered to work on the criteria for scholarship
- ° Set up criteria, determine number of scholarships, amount for each and bring to the board for review/approval
- Present a resolution for unappropriated funds, create line item for board approval

Dennis Savage made a motion to set up, designate additional dollars in a fund specifically for board scholarships and sustain until funds are not available. Lucy Beck seconded the motion.
