	Call to Order The meeting was called to order at 6:01 PM.		
1.	Roll Call Present: Rodely, Rose, McPherson, Still, and West. Absent: Harsy and Waller.		
II.	Reports a. Building Principals -The Reasons We Are Proud items were shared by Mr.		
	Engelmann, Mrs. Woodsides, and Mr. Hickam on behalf of Mr. Hill. (See attachment)		
	 b. Curriculum Director- Mrs. Rea shared updates related to matters of curriculum and instruction including each school's recent participation in the "Brain Games" hosted by the Regional Office of Education and the February Educators of the Month. (See attachment) 		
	c. Operations & Maintenance - Mr. Robbins noted the recent resignation of a custodian at the high school and efforts to fill the position. He also noted a meeting upcoming with a representative from an energy consortium regarding solar energy possibilities. A technical drawing of the softball field with		
	preparations for the installation of turf in the summer was shared with some discussion occurring with the Board including the verification that options were being looked at to extend the height of the backstop fencing. Mr. Robbins also noted that the District would be bidding the mowing contract soon.		
	d. Superintendent - Mr. Hickam noted the District's recent successful effort for a competitive grant through the Illinois Arts Council. Mr. Hickam had Mrs. Rea, as the grant architect, share information with the Board which included the expansion of art instructors so that each school would have a dedicated art		Autoribali
	teacher. This grant is a 3-year grant. Mr. Hickam noted the grant included an agreement with the Tamaroa school district which would allow the sharing of the elementary art teacher and allow Tamaroa students to receive art instruction. Mr. Hickam then shared information on the topic of school safety noting the improvement of the main entrances at the K-8 building in the summer and the improvements in the camera system at the high school. In addition, he noted this		
	year's administration of the 5Essentials Survey and that data from this survey would be used as a means of helping determine student's feelings/perceptions of school safety.


