Board Actions

Motion by Jeremy, second by Moen: to approve the October minutes as presented. Motion carried.

Motion by Neset, second by Hovde: to approve payment of the general fund bills, ck#'s 39553-39597. Motion carried.

Motion by Hovde, second by Moen: to approve payment of the general fund prepaid bills. Motion carried.

Motion by Hovde, second by Neset: to approve payment of the building fund bills. Motion carried.

Principal Reports

Houdek – The Veteran's Program was held November 7 at the high school gym.

Blotsky – MS/HS enrollment is at 261; we received a foreign exchange student. The senior class is serving breakfast to our local protection services on November 20.

Committee Reports

Extra-Curricular

Motion by Aarsvold, second by Hovde: to hire Leon Williams as the C-Squad GBB coach. Motion carried.

Linn Dockter is planning to be done coaching speech in the next 2-3 years.

There are not enough numbers to support hiring a C-Squad BBB coach. There is a college student that needs field experience that is interested in helping with coaching.

Wrestling held a meeting; 1 HS and 6 JH kids showed interest.

There are 6 May-Port girls participating in the girl's hockey program (co-op with Crookston). A parent asked if a school vehicle would be an option to help car-pool the girls to practice.

Motion by Hovde: to not extend the use of the old suburban to the girl's hockey team. A second was called for 3 times, the motion died due lack of a second.

Motion by Jeremy, second by Aarsvold: to approve the Cheer team overnight trip to Bismarck on March 20th. Motion carried.

Motion by Jeremy, second by Aarsvold: to approve the 2 Wrestling overnight trips to Velva (Dec 6) & Linton (Dec 20). Motion carried.

Curriculum & Tech - A team was formed to start evaluating math curriculum; the committee hopes to make a recommendation by spring.

Greenhouse Update: A progress payment of approximately \$20,000 will need to be paid to United Greenhouse.

Co-op Agreements: Hatton-Northwood is interested in treating the softball co-op as a true co-op; we did propose a cost-share and how that would look if they were to fund the middle school program; Northwood is starting a wrestling program, looking into blending the softball and wrestling co-ops; discussions will continue.
