All cost proposals must reflect the LCP (Lowest Corresponding Price), GSA pricing, and any available governmental unit discounts including existing state purchasing agreements or contracts when applicable. Any proposal referencing an existing state purchasing agreement or contract must include that information in the proposal. Bid prices must be complete for the services proposed and

shall include all associated costs, even if the amounts are estimates based upon current applicable taxes, surcharges, or fees.

Proposal shall provide a separate section listing for each building with all costs associated with the proposal for that building.
