Overall average annual District enrollment (including Running Start only) for the 2019/20 school year was budgeted at 4988 FTE.

For district funding and staffing purposes (excluding Running Start and Kelso GOLD), estimated average annual FTE enrollment through Nov. 1 is 4873 FTE. With Running Start (113 FTE) and Kelso GOLD (9.3 FTE), our average annual FTE enrollment through October is 4995 FTE. This is slightly higher than budget.

We can likely anticipate losing 25-35 FTE throughout the school year, bringing our year end average annual FTE enrollment slightly below projection.

Though extremely early in the process, it is estimated that our ending fund balance in August 2020 will be around budget of \$4,000,000, or 5.7% of projected expenditures and transfers for 2019/20.

The budget looks good through the two months of school.

ACCEPTANCE OF AGREEMENT FOR UTILITY SERVICES TO LEXINGTON ELEMENTARY (SCOTT WESTLUND)- Motion Passed

With the assistance of Forma Construction and Construction Services Group we have completed a Contribution in Aid agreement for utility services to Lexington Elementary School. Forma Construction will oversee the installation of the supply line into the Lexington Elementary site on the Kelso School District's behalf.

The agreement will allow Cascade Natural Gas to install a natural gas supply line from their Adams Drive service location in south Lexington, to Boardwalk and Lexington Elementary School. The line will allow for other resident and commercial installs in the area. The line will be maintained and owned by Cascade.

The Contribution in Aid Agreement reflects the excess costs of installation beyond what Cascade is allowed by regulatory agencies to contribute for the project. Excess costs are charged to the requesting owner. The cost of the agreement is \$481,556.35, and reflects an allowance of \$78,000 for Cascade's contribution.

The timeline for the project would provide for a hookup to the property in May 2020. This follows a few months of design and contractor selection, and 6-8 weeks of construction. Cascade will be responsible for all design and installation.

APPROVAL OF SELECTION OF ARCHITECTURAL/ENGINEERING TEAM FOR HUNTINGTON MIDDLE SCHOOL - Motion Passed

After soliciting qualifications for architectural/engineering services for the Huntington Middle School Modernization Project, we have made our selection.

With assistance from Construction Services Group out of ESD 112, our selection team comprised of Mary Beth Tack, Leah Moore, Gary Schimmel, and myself, have conducted a review of qualifications and performed subsequent interviews. Six (6) firms submitted qualifications with four (4) firms selected for interviews: BLRB Architects, Erickson McGovern Architects, LSW Architects, and Integrus Architecture.

We have selected Integrus Architecture to provide the design and project oversight for the Huntington Middle School Modernization Project.

We will begin contract negotiations with Integrus with a projected start date February, 2020 for initial educational specifications and schematic design work.
