5517.01 - BULLYING AND OTHER FORMS OF AGGRESSIVE BEHAVIOR

- Consistent with ORC
- Consistent with ODE Model Policy
- Applies to **students, staff, or third parties**
- To all activities in the District, including activities on **school property**, on a **school bus**, or while **enroute** to or from school, and those occurring off school property
- This policy has been developed in consultation with parents, District employees, volunteers, students, and community members as prescribed
