a.) The 2016-2017 Title III, Part A, Subpart 1 - English Language Acquisition and Language Enhancement Grant application has been completed and submitted to the State Department of Education for approval. The total amount of the Title III Grant is \$11,473.

The funds are to support English Language Learners, and to purchase instructional supplies for use with these students.

b.) The 2016-2017 Bilingual Education Program Grant Application has been completed and submitted to the Connecticut State Department of Education for approval. The total amount of the grant is \$1,855.

The award for this grant is intended to provide children identified as limited English proficient with materials such as native language primary-level print materials, electronic materials, and bilingual primary-level books.

c.) The 2016-2017 Federal Consolidated Grant has been completed and submitted to the State Department of Education for approval. The total amount of the Consolidated Grant is \$333,907. This total includes \$12,133 for the town's parochial schools. The grant is composed of:

Title I, Part A - Improving Basic Programs Operated by Local Educational Agencies - \$236.340

Title II, Part A - Teacher and Principal Training and Recruiting Fund - \$97,567

The grant monies will be applied toward district initiatives in the improvement of instruction and student learning, with a specific emphasis on academic interventions for struggling learners.
