#### **Instructional Best Practice**

Ms. Peck will present an updated overview of the new State Teacher Evaluation System. SEED (CT's System for Educator Evaluation and Development) is an

evaluation and support system that is aligned to the CT Guidelines for Educator Evaluation. It is being piloted in a few districts in the state this year and will roll out for statewide implementation during the 2013-2014 school year. The model was informed by research studies that have consistently found that no school-level factor matters more to student success than high-quality teachers.
