- IV. Reports and Comments of Principals, Committees, and Visitors
- Dr. Bruce Labes entered the meeting at 6:36 pm.

At this time, August Hulse (FFA student representative) provided a handout to the board and gave a brief update. Mr. Hulse reported that seven (7) FFA members and Christina Hoffman would be attending the National Convention in Indiana at the end of the month. Ms. Hoffman then introduced herself to the board and added that 1st and 3rd hour welding classes will be working on the handrail for the bridgeway.

V. Report of Superintendent

ACT Changes. Superintendent Vignery advised that starting next fall, ACT will be allowing students to retake one (1) section at a time to improve their score; students will have the option to take the test online vs. paper/pencil (results back within two days vs. six weeks); and, other possible updates. Mr. Vignery also advised that the legislature has directed that districts give the Pre-ACT to all 9th graders. Mr. Vignery added that we would be giving the pre-test to all 10th grade students this year, as well.

• LED Update. Superintendent Vignery reported savings from last March through this September's electrical bill are approximately \$19,000, since the LED upgrade.

VI. Old Business

- a. High School Eligibility. Ryan Mortimer indicated that the Jr-Sr high school staff would like to separate the Homework Club from the eligibility policy, as they have seen good results from the Club. MJSHS will continue to utilize the eligibility policy outlined by KSHSAA. In support of the Homework Club, teacher John Darrow gave a handout to the board and summarized the success the teachers have seen so far this year. Mr. Darrow added that the Homework Club is open for all students this year and is held during CC (Career Cruising) time.
- b. Football Field Update. Mr. Vignery reported that Jim Bateman was unable to attend the October meeting. Mr. Vignery related that Mr. Bateman is currently in conversations with potential investors; the foundation is set up and in place; information will be provided through the newspaper, social media, and half-time during home games. Between artificial turf and sod, the board has until March to make the ultimate decision. President Nelson asked if a new board was elected in November, how would the vote made on April 3, 2019, be affected. Mr. Vignery responded that the board would have to rescind the previous action taken to make ay changes.
