REGULAR MEETING<br>BOARD OF EDUCATION

December 09, 2019

## 1. CALL TO ORDER:

The Board of Education of Community Unit School District \#3, Fulton County, met in regular session on December 9, 2019, in the Cuba Elementary Library, 652 East Main Street, Cuba. President Sue McCance called the meeting to order at 6:30 P.M.
2. ROLL CALL:

## 3. PLEDGE OF ALLEGIANCE:

President McCance led the Board in the Pledge of Allegiance.

## 4. RECOGNITION OF PUBLIC:

Katlynn Beekman (STEAM), Brad Mercer (Innovation Academy), Rachel Slater (STEAM) and Maranda Viano (STEAM-ART) were in attendance to show the board the progress of the "STEM/STEAM" project, they showed the board some of the things they have made with the 3-D printer, such as a turtle that with gears that turned so that it looked as though it was swimming, a house, and a dog to mention a few. They also brought the Lego Microbots that they control by I-Pads. They are excited to learn about coding so that they can program the Microbots to do specific commands. They also showed the board some of the items that they have helped the Elementary students complete such as a crab which they made out of clay using the students hands, and noted how they had to prepare tasks to keep the kids busy. They feel the STEM/STEAM project will help them in the future with problem solving, planning, and organizing.
