

## **Newell School District Back to School Plan**

### **Mission Statement**

Newell School District desires safety for students and community members from communicable diseases such as Covid-19. We believe the school environment gives students the best chance to succeed academically, socially, and emotionally. There is a need for group effort from parents/guardian(s), school personnel, and students ensuring school safety for learning.

### **Back to School committee members:**

### **Parent Expectation**

- Parents are an integral part of school safety.
- Make sure child(ren) practice good hygiene skills such as washing hands after using the restroom or touching surfaces that have been touched by other individuals.
- Make sure child(ren) are properly hydrating themselves throughout the day.
- Please have students bring a sanitized water container daily to ensure that proper hydration.
- Parents/guardians should discuss the back-to-school plan with their child(ren).
- If parents/guardians need document translated into another language, they can call the school at 605-456-2393.

### **Students' expectation**

- Students need to practice good hygiene such as sanitizing hands before entering classroom, while entering and exiting restrooms, before and after recess(es), before and after eating, and before and after sporting practice/competitions.
- Students have the option to wear a mask to school but is not mandated.
- Social distance yourself as often as possible on school buses, classrooms, cafeterias, and other rooms throughout the school.
- Students will report to the central office in their appropriate building (K-8 Mrs. Dirk's office and 9-12<sup>th</sup> Mrs. Lamphere's office) if they are late to school for any reason.

### **School District Personnel Expectations**

- Newell School District personnel will create an environment in school to reduce the spread of germs.
- Newell School District personnel will educate students on proper health etiquette throughout the year.
- Newell School District will socially distance students as much as possible throughout the school day.

- Newell School District will provide proper air quality to students and staff through an air filtration system which was installed in every building on campus during the 2020-2021 school year.
- Teachers and bus drivers will have assigned seats for each class period for ease of contact tracing.
- Newell School District will provide the following services to families if school were to be closed: food services through food delivery during school days, academic needs through google classroom and packets with instruction, staff, and student mental and emotional needs through virtual counseling.

### **Safety Protocol and procedures by school personnel**

- Students will be socially distanced as much as possible in the classroom.
- Surfaces touched by students will be sanitized daily by school personnel.
- Hand sanitizer stations will be found throughout the buildings and will include stations between classrooms, at entrances, in front of restrooms, and in the lunchroom.
- Preschool students will meet rides outside the west doors in the elementary. School personnel will help students to this destination.
- School transportation will be sanitized by school personnel after every use.
- Students will be released in intervals to eat as a class during lunch.
- Students will have four minutes between all classes and will need to follow signage in buildings for transitions.
- Any protocols to ensure health and safety in accordance will be followed.
- Newell School District will not be providing Covid-19 testing in school due to not having a school nurse. If parent(s)/guardian(s) suspect child has Covid-19, they can get tested at a local clinic.

### **Covid-19 positive test and contact procedures**

- Students and staff members that test positive for Covid-19 will be sent home for 5 calendar days from the onset of their symptoms. School officials will gather homework from the student's teachers and send the assignments home.
  - After 5 days, students can return to Traditional learning as long as they are symptom free (<https://www.cdc.gov/coronavirus/2019-ncov/downloads/php/CDC-Activities-Initiatives-for-COVID-19-Response.pdf>).
  - After five days from symptom onset, administration will call parent/guardian or staff members to see if they are symptom free.
  - After five days from symptom onset, student and staff are recommended to wear a mask for an additional five days.
- Close contacts to positive Covid-19 individual can come to school without a mask if they do not exhibit Covid-19 symptoms.

### **Phases for Instruction**

Administration and the Newell Board of Education will use data from local hospitals, county health personnel, South Dakota Department of Health, Center for Disease Control (CDC), and South Dakota Department of Education to decide the education phase for the Newell School District. Please note that this process is an ongoing process throughout the school year.

1. Phase **ONE**- Traditional learning with safety procedures in place while preparing parents and students for possible remote learning.
2. Phase **TWO**- One or more positive Covid-19 student or staff cases are in a school building. Rooms that have had a positive case Covid-19 will be thoroughly cleaned afterwards due to DOH recommendations.
3. Phase **THREE** -If multiple students/staff members with a positive Covid-19 test are in one building such as the high school, middle school, or elementary school, deep cleaning of the school will occur for five days and students in that school will do Remote learning for the five days.
  1. All extra-curricular activities in the building that is being deep cleaned will be postponed for the five-day period.
4. Phase **FOUR**- If multiple buildings such as the high school, middle school, or elementary school have multiple students that test positive for Covid-19, deep cleaning will occur the entire school for five days and students in the district will be doing Remote learning for the five days.
  1. All extra-curricular activities in the building that is being deep clean will be postponed for the five-day period

### **Extra-curricular activities**

Students that participate in extracurricular activities do not have to wear a mask during practice or competition if they are a close contact or are symptoms free after five days from symptoms of Covid-19.

### **Covid-19 Vaccination**

The Newell School District believes that Covid-19 vaccinations for students and staff are a personal choice. If a student or staff is interested in the Covid-19 vaccination, they can contact Monument Health at 605-755-1350 to set up an appointment for Covid-19 vaccination.

This is a living document that is subject to change based on the Covid-19 pandemic in the region and the state. The Newell Board of Education, along with administration, South Dakota Department of Health, and the South Dakota Department of Education, will work together to adapt this document throughout the school year.
