MINUTES

1. CALL TO ORDER

Chairman Preston called the meeting to order with a reminder that the mission of the Board and Lawrence County Schools is *Every Child College and Career Ready; A Community Involved and Informed.* He led *The Pledge to the United States Flag.*

2. APPROVE AGENDA

Approval to amend the agenda to include additional items, **5.D.3.c.2.** Overnight LCHS school trip to State Tennis Tournament, **5.D.3.d.1.** Addition of Melissa Ratliff and Angel Ward to Permission to apply for Learning Innovation Grants through KVEC, **5.D.3.d.4.** Permission for LCHS to apply for KVEC's "Tiny House" Purpose Driven Learning Opportunity Grant, passed with a motion by Ms. Garnett Skaggs and a second by Mr. James See by a vote of 5 to 0.

3. STUDENT/STAFF PRESENTATIONS/RECOGNITIONS

Dr. Fletcher led a moment of silence in memory and respect on the passing of former employees for their service to the students and staff of Lawrence County Schools. Cheryl Vanover was a former Blaine bus monitor, and Lawrence Edward Vinson was a former Lawrence County school board member and bus driver.

3.A. LCHS Youth Career Connect (YCC) Medical Student Internship Project

As part of the final year of the Youth Career Connect (YCC) grant, ten students in the Biomedical Science and Pre-Nursing Pathways, independent of required courses and schoolwork, participated in a medical project-based internship in collaboration with Dr. Spencer Harris, a Lawrence County High

School graduate and physician at Riverview Family Clinic, and Mary Adams, LCHS Counselor and YCC Career Counselor. Students met with Dr. Harris weekly, selected a health focus area, conducted surveys and collected data from middle school students throughout the county, completed research and presented findings to all of the middle schools in the district. Each student gave a summary of their project and findings to the Board and shared insight on the impact the experience had on their readiness for a career in the medical field and their personal growth. Dr. Harris spoke highly of the sincerity and commitment of the students and Mrs. Adams noted that students committed to the project "just for the experience" not knowing until later that they would earn a monetary award for their successful completion. Dr. Fletcher congratulated the students on "impressive work" stating that as they face other research tasks in college, they will be "research-ready". He presented certificates of recognition to the students and to Dr. Harris and Mrs. Adams for their work with and support of students throughout the internship. He thanked Dr. Harris for the time he gave mentoring the students noting that the school district is blessed with many good community partners. Students completing the internship are Katelynn Boggs, Presley Boyer, Mykelia Brooks, Emily Burke, Alex Ratliff, Austin Ratliff, Ellan Sparks, Randa Thompson, Emily Vance, and Brooke Walker.

3.B. Outstanding District and School Volunteers

Dr. Fletcher stated that our schools are blessed with dedicated volunteers, some that are often mistaken for school employees they are such a part of the daily school environment. School Outstanding Volunteers were presented plaques: LMS, Pam Hay; LWES, Shiloe Ham; LEES, Atasha Hughes; LCHS, Ginger Copley; FES, Marla Spillman; BES, Pam Maxie. Blaine's Pam Maxie with 1,228.75 volunteer hours was named District Volunteer of the Year. Blaine volunteer Jennifer Boggs also was recognized and received a plaque for having over 1,000 hours. She had 1,125 logged volunteer hours. Total volunteer hours logged at each school are as follows: Louisa Middle with 97; Louisa West with 143.08; Louisa East with 222.26; LCHS with 142; FES with 2,617, and winner of total school hours is Blaine Elementary with 3,065.25. Dr. Fletcher announced the district total of 6,286.59 hours thanking all volunteers for their dedication to our students and schools.

4. COMMUNICATION

4.A. Superintendent's Update

4.A.1. Partnership with ACTC students (12) registered in 4 areas

A special partnership has been developed with ACTC to allow more students to enter career-technical fields not offered at our high school, such as auto mechanics, electrical, industrial maintenance, and welding. Interested students and their parents met recently to learn about and commit to the ACTC courses. Twelve students have registered. Students will sign learning contracts and contracts for driving privileges to commute to ACTC for a half or full day for training in their chosen field.

4.A.2. Computerized manufacturing and machining field trip

Computerized manufacturing and machining is another training area that ACTC can offer. Principal Moore stated that after the field trip on Friday to learn more about this career field, several students are interested in registering for it.

4.A.3. Research on a partnership for computer technology/information technology

Dr. Fletcher announced that research is ongoing for another opportunity, one with Lycom for a partnership for training in computer technology/information technology, made possible through a grant.

4.A.4. JROTC program hosted awards/promotion ceremony

Dr. Fletcher praised the success of the high school's JROTC program under the leadership of Colonel Turner and Sergeant Runyon. The program had been in probation prior to their leadership and recently earned the title of Program of Distinction. The drill team placed 15th in the nation and even presented the "colors" at a Cincinnati Reds game this spring in addition to other awards earned by other cadets.

4.A.5. Viewing of Chalk in the Blood: A Brief History of Education in Lawrence County (7PM Thursday)

A Brief History of Education in Lawrence County, an hour-long documentary created by students under the mentorship of high school teacher David Prince will have its first public viewing on May 23 at 7 p.m. in the Lawrence County High gymnasium. The documentary was made possible through one of the \$1,000 Innovation Grants awarded to teachers in our district as part of our membership in KVEC. Much research and hours of filmed interviews were conducted by students including interviews with former Governor Paul Patton and retired educators throughout the county, including Blaine, Fallsburg, and Louisa. The documentary begins with a voiceover description of Lawrence County Schools by William (Bill) Cheek, former Superintendent of Schools from 1938-1974.

4.A.6. LC hosts Regional Tennis, District Baseball, District Softball Tournaments

Dr. Fletcher noted that the entire campus on Bulldog Lane was busy with competitions while the board meeting was in session including regional tennis matches and district baseball and softball tournaments.

"To cap off a busy week, graduation is set for Friday at 7 in the high school gymnasium".
