MINUTES

1. CALL TO ORDER

Chairman Preston called the meeting to order with a reminder that the mission of the Board and Lawrence County Schools is *Every Child College and Career Ready; A Community Involved and Informed.* He led *The Pledge to the United States Flag.*

2. APPROVE AGENDA

Approval of the agenda as presented passed with a motion by Ms. Maddlene Roberts and a second by Mr. James See by a vote of 5 to 0.

3. STUDENT/STAFF PRESENTATIONS/RECOGNITIONS

Dr. Fletcher led a moment of silence in memory and honor of Darlene Young, a retired, longtime Home Economics teacher with Lawrence County Schools.

3.A. Fallsburg Elementary Presentation

3.A.1. Junior Master Gardener Club

What began as an idea for an enrichment class, to beautify the school, has turned in to a well-planned and community supported project for students – Fallsburg's Little Gardeners Club. Teacher sponsor Craig McDavid, Vice-President Bryant Moore and club member Rheanna Bateman explained their goals and discussed current club projects and accomplishments so far this year and their future goals. The club has written a constitution

and elected officers, had its first monthly cleanup day, created butterfly gardens, including a Monarch Butterfly Waystation, and a pollinator garden and started its first fundraiser. The club's large project for the year is to revitalize the existing, but un-usable, nature trail which crosses a small stream, passes a pond and follows the ridge line returning to the school parking lot. Fundraising will go to building a bridge across the stream, signage, and materials for birdhouses and bat houses. Lawrence County Master Gardeners Sandy Jobe and Cathi Wells were introduced and they explained how they had been involved with the club and future projects they hoped to involve the students in such as Big Sandy Water Watch and to help bring life back to the pond. Other outside resources and community partners include Lawrence County 4-H, Conservation Officers, Wellman's Hardware, Asplundh, Kentucky Power and Marathon. Dr. Fletcher thanked the students for their interest in the school stating that they as leaders of the school are setting examples for other students. On behalf of the Board, he presented certificates of recognition to the students and Mr. McDavid and thanked the community partners for their support and "for everything you put back into our schools and our students."

4. COMMUNICATION

4.A. Superintendent's Update

4.A.1. LC teachers will receive 8 KVEC Innovation Grants.

Dr. Fletcher extended congratulations to eight of our teachers who will receive approximately \$1,000 each going directly to their classroom for projects. Teachers and projects: Andrea Rowland (LEES) – Phonics VIP; Courtney Kingsmore (LEES) – Engaging Students and Improving Performance on Formative Assessments; David Prince (LCHS) – Education in Lawrence County – a Brief History; Emma Price (LCHS) – READ in Spanish; Erin Giesler (BES) – Flexible Seating for Focused Learning; Kimberly Shirkey (LCHS) – "Lights, Camera, Action" Student Problem Solving Comes to Life; Melissa Blackburn (LCHS) – Watch Me Grow Gardens; and Susan Adams (LEES) – Turning Tables for Learning. Teachers will present their projects in October at the Innovation Summit held at the Pikeville Expo and return in April to present the results.

4.A.2. Blaine Elementary receives a \$10,000 Steele-Reese Foundation Grant.

Dr. Fletcher congratulated Librarian Stephanie Kirk once again on receiving a Steele-Reese Foundation Grant to complete the renovation of the school's media center. Improvements include new furniture and book shelves, paint, and upgrades to technology.

4.A.3. Rhonda Colvin served on the state-wide cut score setting committee.

Dr. Fletcher stated that Lawrence County Director of Special Education Rhonda Colvin is recognized as a leader across the state and recently served on the state committee setting the cut scores for the new Accountability System.

4.A.4. Dr. Fletcher is serving on KASS and KVEC committees to develop position papers.

Dr. Fletcher is serving on KASS and KVEC committees to develop position papers on issues of concern to present to legislators. One priority item is increased pay for all school employees. "Everyone in education deserves a raise." Other issues include the need for textbooks in the classroom and the retirement system. Dr. Fletcher noted that the issues being addressed in the KVEC committee are more centered around unique Eastern Kentucky needs, such as transportation which is much more costly than in urban areas.

4.A.5. Dr. Webb and Dr. Fletcher are completing instructional walkthroughs in all schools.

Dr. Fletcher stated that he and Dr. Webb are half way through instructional walkthroughs with the goal of visiting every class in our schools.

4.A.6. State test data is set to release soon: CSI vs. TSI schools.

State assessment data from last spring will be released at the end of this month. Based on the data, schools can also receive a designation of support. Schools may be identified as in need of Comprehensive Support and Improvement (CSI), which is similar to the former Persistently Low-Achieving (PLA) designation and is estimated to include about 50 schools, or they may be designated as in need of Targeted Support and Improvement (TSI), which would be for a particular sub-group such as Students with Disabilities or Free/Reduced Lunch which will include about half the schools in the state.

4.A.7. District Facilities Planning Forum and BOE meetings are set for September 28th.

The final public forum for input into the District Facilities Plan will occur at a Public Hearing followed by a Board of Education meeting on September 28th.

4.A.8. A reminder: All retirees from LC Schools are eligible for a free pass to ball games.

Dr. Fletcher gave a reminder that when you retire from Lawrence County Schools, you can stop by the Board Office and pick up the Retired Bulldog Activity Pass which gets you into regular season ballgames other events free of charge. Board member Jim See added that the lifetime activity pass is also available to all former and current military personnel.

"With this purchase, every bus plus three spare buses will be outfitted with camera systems," Dr. Fletcher stated. "This is a good investment in the safety of our students. It protects our kids and our employees and saves hours of research."

6. PERSONNEL

6.A. Superintendent Professional Growth and Evaluation System (SPGES) Update Dr. Robbie L. Fletcher, EdD

6.A.1. Standard 5 Managerial

Dr. Fletcher noted that a long road, the District Facility Plan process conducted every four years, will be finishing up on September 28. Managing the process which began last school year is part of Dr. Fletcher's growth plan. The Plan contains needed projects throughout the district including a separate gym and cafeteria at Fallsburg and Blaine, a parking lot at Blaine, a new Louisa Elementary School, and other projects throughout the district such as roofs and guttering. It outlines about \$41 million in unmet need and about \$17 million for the new Pre-K-1 school. The next step after the hearing and board meeting on September 28 will be for the plan to go to KDE for approval.

6.A.2. Standard 7 Influential

Noting that the Board has challenged him to be an influential leader both within and outside of our district, Dr. Fletcher reviewed his involvement in NISL, KEDC Board of Directors and Steering Committee, and leadership in KVEC in meeting this leadership standard.
