Motion by Stevenson, second by Krager to approve Jill Johnson as Elementary secretary at \$13.00. Carried 3-0.

Carried 3-0.

Motion by Stevenson, second by Krager to accept bid from CPI to install new phone system at the cost of \$41,505.00 Carried 3-0.

Motion by Krager, second by Stevenson to increase graduation credits from 46 to 48. Students now get full credit for band, choir and PE so increase will take that into consideration. Class of 2019 or 2020 will not be affected. Class of 2021 will increase to 47 and class of 2022 will increase to 48. Carried 3-0.

Superintendent Slater gave his report.
