### Call to Order

Chairperson Alcombright called the meeting to order at 7:45 p.m.

The School Committee will discuss the site visits and organize final interview questions.

Jake Eberwein reviewed the documents that were provided to the school committee members in advance of the meeting. He then reviewed the format of the interview.

A greeter should meet the candidates and bring them to a waiting room. Ellen Sutherland served in this capacity for the semi-finalist interviews and will serve again for the finalists. Candidates should be given a visual of the interview space and asked how he/she would like to be introduced (i.e. Dr., Mr. /Mrs., first name.) At the appropriate time, the candidate is brought into the interview and the Chair introduces him/her to the Committee and Committee members introduce themselves.

The formal interview begins with a very open ended question which gives the candidate a chance to make an opening statement. It is important to be clear about the time and the management of time.

There are generally 8-12 questions. Mr. Eberwein cautioned that follow up questions are challenging and the search committee did not elect to do them as they can get you off pace. If they are done, they should go through the chair and back to the candidate. After the questions, the search committee gave each candidate a chance to ask a questions or make a closing statement or emphasize anything he/she was not able to talk about in the interview or emphasize something from the interview.

Once the interview has been completed, the Committee will begin deliberations and discuss strengths and weaknesses of each candidate.

The Committee members each took turns proposing questions and receiving feedback from the fellow committee members and Mr. Eberwein. The questions and format agreed upon are attached.
