Dr. Jancek presented his proposal for salary rate increases for the Support Staff for the 2022-23 school year. He is proposing a 5% increase across the Board, as well as bringing some individuals up just under the 6% threshold because of the difficulty of getting people interested in employment here at the school. He also discussed the new proposed sub rates, as well as new starting pay rates for different job categories. Dr. Jancek also introduced a proposal to have different tiers of Teacher Sub pay, based on the number of days they serve in the district in a given school year. He proposed \$115 for days 1-20; \$120 for days 21-40; and \$125 for days beyond 40. The Boards were in agreement with Dr. Jancek's recommendations.
